## NOTIFICATION OF VEHICLE CHANGE FROM PERSONAL USE TO BUSINESS USE

- Taxpayers must notify the Commissioner of the Revenue when a vehicle changes from Personal Use to Business Use.
- A vehicle is designated as having "business use" when:
  - o the vehicle is used over 50% of the time for business purposes OR
  - o a business vehicle tax deduction (depreciation and other expenses) for the vehicle has been claimed on the federal income tax return of a business or individual by the filing of a:
    - Schedule C Form 1040/Profit or Loss from Business
    - Form 2106 Employee Business Expenses, or
    - Form 4562 Depreciation and Amortization Schedule

- Note that vehicles designated for "business use" do not qualify for Personal Property Tax Relief Act (PPTRA).
