The Winchester Regional Airport Authority met in regular session in the conference room of the terminal building at 5:00 p.m., June 14, 2018.

OPEN MEETING

Chairman Fisher called the meeting to order at 5:00 p.m.

APPROVE MEETING AGENDA

Chairman Fisher requested an amendment to the agenda under Item 4 a – Confirm Appointment of New Executive Director.

CHAIRMAN - OPENING REMARKS

Chairman Fisher announced that he had received a phone call from the Mark Flynn Director of the Virginia Department of Aviation that Renny had been selected to receive the Lifetime Achievement Award at the annual Virginia Aviation Board Conference in August of 2018 in Norfolk, Virginia. The chairman and other board members congratulated Ms. Manuel on a job well done and in being selected for such a deserving award.

Chairman Fisher read the following proposed motion:

Chairman Fisher informed members that staff is going through some challenging times with the recent vacancy in the CSR position and trying to fill that position but then the account clerk Angie Lamm gave her notice that June 24, 2018 would be her last day of work. Ms. Lamm informed

Renny that she begins a new job on June 27, 2018. He added that the director had been spending more time at the airport than she should be lately but that was attributed to her dedication.

COMMITTEE REPORTS

(a) Finance Report – Secretary/Treasurer J. J. Smith

Mr. Smith presented the finance reports for the month of June 2018. He stated fuels sales were up slightly over prior year sales. The year to date income was still positive however it was slightly lower than prior year. Following brief discussion a motion to approve was made.

Mr. Smith noted that Ms. Manuel had sent out copies of the FY 2017 financial audit report recently completed. He explained various numbers and key items in the audit report. He stated that the financial position of the WRAA was in the black.

EXECUTIVE DIRECTOR COMMENTS

Ms. Manuel briefed the board about an upcoming project for demolition of residential structures on five parcels all located on Bufflick Road that were acquired over the past several years. The project is the T/W "A" Relocation Phase 1 – Residential Demolition and will funded through Federal and State grants at 98% funding level with 2% local match. The project had gone out to bid with a bid opening June 21, 2018.

She also provided an update on the Phase 1 – Site Design for New Terminal Building regarding funding from the Virginia Department of Aviation. The project has been approved however there still is not enough money in the general aviation fund to award a grant. Through the Virginia Airport Operator's Council legislation was submitted through a sponsor and passed to allow the Virginia Aviation Board to move monies from one funding group to another during the year after the first six months. Recent years the Air Carrier/Reliever fund has had a multi-million dollar balance left after award of that class group's funding request. After January 1 of each year the VAB will be able to transfer leftover money into the General Aviation fund as needed. The funding request for the Phase 1 – Site Design has been submitted to the VDOA for their August meeting. If funds are not available at that time the project will continue to be resubmitted throughout the year.
