Chairman Fisher called the meeting to order at 5:00 P.M. Chairman Fisher requested to remove the Finance Report from the meeting agenda, as it was identified that capital revenues were input erroneously and need to be corrected. A report will be available at the next meeting.

Robert Kline made a brief presentation about his business, On Wing, and their plans to expand. In support of these plans, On Wing has started discussions with the Executive Director to potentially lease the airport corporate hangar.

The airport is exploring changing the UNICOM frequency to one that is not used by nearby airports in an effort to reduce unnecessary radio congestion.

The maintenance work scheduled for mid-September was canceled due to wet weather and is rescheduled for the first week in October.

The preconstruction meeting for the capital project to demolish four houses on Bufflick Road is scheduled for September 22<sup>nd</sup>. We expect to give Notice to Proceed (NTP) shortly after.

On October 22<sup>nd</sup> from 5:30-7:30, the airport is hosting a stakeholder expo aimed at educating and informing elected officials about the airport and future vision. All board members are encouraged to attend.

There are upcoming events aimed at engaging the local pilot community. On October 23<sup>rd</sup> there is a seminar on how to start a flying club and on November 10<sup>th</sup> there will be a "Rusty Pilots" seminar.

Nick expressed support for On Wing and said the airport was doing everything it could to facilitate their leasing of the airport's corporate hangar. Gene added that Paul could review a draft lease on behalf of the building and lease committee, and the board would accept their recommendation.

Nick concluded his comments by discussing the airport's role in natural disasters, including use as a potential staging area and a fuel stop for emergency aircraft operations.

### **COMMENTS - BOARD MEMBERS**

**Paul Anderson –** Paul expressed his support for On Wing and that he feels it is important that a capable avionics shop is located at the airport.
