

Frederick County Sheriff's Office 2012-2013 Goals and Objectives

- Complete the implementation of the Frederick County Sheriff's Office Forward Mobility Project to implement a secure VPN connection between the Sheriff's Office and mobile users. This will be accomplished through the purchase of a NetMotion Wireless Mobility XE software package and compatible server. This increased access will provide for more time in the patrol vehicle, and less time at the office. This will also allow for a safer environment for the Deputies due to their access to critical safety data while in their vehicle and in contact with the public. This software will also allow for necessary updates to be pushed through the NetMotion product without the user having to manually update in person with the information Technologies Section.
- Maintain the Virginia Law Enforcement Accreditation standards set forth for review in 2015.
- Enhance law enforcement and community relations through deputies performing civic duties such as child fingerprinting, Sheriff's Kids Camp, the D.A.R.E. Program, Neighborhood Watch meetings, and updating the Frederick County Sheriff's Office website.
- Reduce traffic related deaths in Frederick County by increasing traffic enforcement efforts on the highways of Frederick County.
- To upgrade current law enforcement equipment with more modern technological advancements. To improve officer and community safety by providing less lethal alternatives to the use of deadly force.
- Increase crime prevention activities in the community. The Sheriff's Office believes one way of reducing crime is through education. This education provides the public with information and suggestion on home, business, and Internet security, as well as personal safety. Local cable channel 16 lists safety tips, current criminal activity or frauds, as well as wanted people.
- To work with County IT to improve security on the maintenance and storage of criminal records as mandated by the FBI Criminal Justice Information audit.
- Work with other County agencies, Board of Supervisors, and citizens of Frederick County to continue to provide the quality of life that our community has come to expect.
- To seek funding sources to provide School Resource Officers in all Frederick County Public Schools.

Sheriff's Office Activities

Accreditation

Frederick County Sheriff's Office achieved reaccredidation in July 2012. The Sheriff's Office received their initial accreditation in June 2007. The accreditation process provides assessors from other law enforcement agencies in Virginia who reviewed Sheriff's Office policy and procedures. The Sheriff's Office met over 700 standards to achieve this award. The Sheriff's Office strives to provide professional law enforcement services to the community.

Frederick County Fair

The Frederick County Sheriff's Office patrols the Frederick County Fair the entire week of the fair. The Sheriff's Office presence at the fair provides a safe environment for everyone attending, so that everyone can have a good time. The fair also provides deputies from the Sheriff's Office and the public an opportunity to interact and develop positive relationships.

Community Presentations

The Frederick County Sheriff's Office presented numerous community presentations throughout the community in 2012. The Sheriff's Office participated in 2 events at Rutherford's Crossing, National Night Out and their Halloween celebration. The Sheriff's Office promotes and provides speakers to the various Neighborhood Watch Programs in Frederick County.

Investigator James Galbreath, a member of the Internet Crimes Against Children Task Force, has given several community presentations on Internet crimes and the impact on children. The Sheriff's Office reminds all parents to monitor their child's activity on the Internet.

Frederick County D.A.R.E Program

The Frederick County Sheriff's Office provides the D.A.R.E. program to the 11 elementary schools for Frederick County Public Schools. Almost 1,000 students participated in the D.A.R.E. program in 2012. The Sheriff's Office has received numerous accolades on Deputy Bowers' performance from students, teachers, and school administrators. The Sheriff's Office would like to thank all of the business and individuals who contributed funds to the D.A.R.E. program and Frederick County Public Schools for their continued support of the program.

Click it or Ticket

The Frederick County Sheriff's Office participated in the 2012 annual Click it or Ticket program sponsored by the National Institute for Highway Safety and administered through Virginia's Department of Motor Vehicles Drive Smart Virginia Program. Special enforcement activities were used to increase enforcement of the seat belt laws in Frederick County. Road checks and roving patrols were implemented throughout the county to ensure that drivers and passengers complied with Virginia's seat beat laws.

Click It or Ticket is a high visibility enforcement program designed to improve safety belt usage and save people from death and serious injury on the streets and highways, according to the website safeandsober.org (http://www.safeandsober.org).

Virginia's statewide safety belt compliance rate is currently 81.81 percent, the website states.

The twice yearly Click It or Ticket campaign is made possible by a grant from the Department of Motor Vehicles, which allows local law enforcement agencies to have extra patrols, Richardson said.

Frederick County Sheriff's Office Youth Camp

The 15th annual Frederick County Sheriff's Office Youth Camp was a great success. Approximately 80 local children attended and helped with the weeklong camp at Camp Rock Enon. The campers and junior counselors enjoyed repelling, swimming, archery, and several athletic competitions. The Frederick County Sheriff's Office would like to thank the businesses and individuals who support the Youth Camp each year with their donations.

Man Tracking Training



The Appalachian Professional Tracking Group (APTG) conducted a three-day tracking course for Law Enforcement Officers. The APTG is affiliated with Joel Hardin Professional Tracking Services (JHPTS). JHPTS is a nationally recognized as the standard for professional tracking training in the Search & Rescue, Law Enforcement, and Military environments.

This was a 24-hour basic tracking course specifically designed for Law Enforcement Officers. The course included classroom and field experience exploring tracking fundamentals and learning to identify visual footprint evidence that may have gone previously unseen. Students will be able to properly identify a specific footprint, track that specific footprint by determining simple aging factors in relation to, or in comparison to, other footprints.

After receiving this training the Frederick County Sheriff's Office established its own tracking team. The Sheriff's Office tracking team has been used several times since its inception to track for evidence and search for missing people.

New Technology

The Frederick County Sheriff's Office received funding to begin the process to have access to DMV and VCIN/NCIC in all of the its vehicles. The first step was to purchase and issue new laptop computers to all sworn personnel. Vehicles were out fitted with new radio/computer stands for the computers to be used in the vehicles. The new computers have Internet access so that the deputies can currently access Sheriff's Office programs, thus allowing deputies to submit incident reports from the field, eliminating a trip back to the Sheriff's Office. The final phase is to secure funding to purchase the software that is needed to access DMV and VCIN/NCIC.

The Sheriff's Office purchased two Total Stations April 2012 from a federal grant. The Total Stations will be used to produce more accurate and animated drawings of crime scenes and vehicular accident scenes. Several Sheriff's Office members were sent to training to lean how to use this new technology. The Sheriff's Office issued new digital voice recorders to all deputies in 2012. These recorders will allow the deputies to record statements for up to six hours before being downloaded onto a CD. The Sheriff's Office will save money by not having to purchase cassette tapes for the deputies.

The Sheriff's Office completed purchasing and installing new narrow band mobile radios in all of its vehicles. The Federal Communications Commission had required this conversion of all radios to narrow band capability by January 1, 2013. The Sheriff's Office is now in compliance with this new federal mandate.

Computer Forensics

Investigators Tim Juergens and Bryce Davis completed several rigorous months of computer forensic training and both of them achieved certification as forensic examiners. Their certification allows the Sheriff's Office to do in-house computer examinations, eliminating the previous practice of sending the computers to outside agencies to have them examined. The turn around time to have computers examined by outside agencies was approximately 6 months. The Sheriff's Office seizure of computers used in crimes has continued to increase over the past few years. Since more computers are now used for illegal activity, the Sheriff's Office determined that in-house examinations would be more efficient in the prosecution of criminal offenders.

High Profile Criminal Case

Fugitive spotted on reality show appears in court

Authorities say suspect in sex crime fled country to avoid trial 10 years ago

A man authorities say fled the country to avoid trial on a sex crime charge pleaded guilty Tuesday for failing to appear in court 10 years ago. William Edgar Dick II appeared in Frederick County Circuit Court with his attorney, public defender Timothy Coyne. Dick, 30, with a last known address of Polk City, Fla., pleaded guilty to the felony charge of failing to appear in the court Jan. 9, 2002. Retired Judge Benjamin Kendrick accepted the plea.

Kendrick set Dick's charge of forcible sodomy for a jury trial April 27. The judge delayed sentencing on the failure to appear charge until the same date. Commonwealth's Attorney Glenn Williamson did

not object to continuing Dick's sentencing to the April date. Dick remains held at the Northwestern Regional Adult Detention Center.

Authorities accuse Dick of committing forcible sodomy against a male victim on June 10, 2000. A grand jury indicted Dick on the charge a year later, court records show. A judge scheduled his jury trial for Jan. 9, 2002, but Dick failed to appear. Authorities searched unsuccessfully for the defendant, who was declared a fugitive by the court.

Investigators with the Frederick County Sheriff's Office continued to look for clues into Dick's whereabouts and had hints he may have fled the country, possibly to Costa Rica. In 2010 an investigator received a tip from a friend of the alleged victim in the sodomy case that the fugitive had appeared as a bartender in an episode of the MTV reality show, "The Hills," which the network filmed in Costa Rica. Further investigation confirmed Dick appeared in the episode under a different name, according to documents filed in U.S. District Court in Harrisonburg.

A federal judge in U.S. District Court in Harrisonburg on Oct. 25, 2010, issued a complaint and a warrant for Dick's arrest for unlawful flight to avoid prosecution. Costa Rican authorities handed Dick over to United States custody, although extradition policies and other hurdles had delayed the process for months. Dick returned to the U.S., and ultimately Frederick County, in August. A Frederick County Circuit Court grand jury indicted Dick on the charge of failing to appear in September

K-9 Donation from Local Business Owner

Larry Omps, the owner of Omps Funeral Home and Cremation, was the local benefactor who donated two dogs to Frederick County's K-9 unit. In the past the Frederick County Sheriff's Office had four working K-9's. By December of 2011 the Sheriff's Office was down to one K-9, Max. Unfortunately, Max died suddenly in January 2012 leaving the Sheriff's Office without any K-9s.

Mr. Omps decided to purchase and donate to the Sheriff's Office two K-9s out of funds from the All Pets Cremation Center. All Pets Cremation Center provides funeral services for pets. Mr. Omps stated that after hearing about the county's budget crunch, "I wanted to do the small part I can do to keep you all in operation." Deputy Pyles found Saro, a 16-month-old Belgian Malinois and Dutch Shepherd mix, and Dax, a 3-year-old German Shepherd for the Sheriff's Office. Sheriff Williamson said the cost of both K-9s was \$7500. The K-9s were both trained to be full service patrol dogs specializing in tracking, narcotics, and apprehension. Both K-9s are in service and working with their handlers, Deputy Pyles and Deputy Walther. The Sheriff's Office would like to thank Mr. Omps for his generous contribution.








Busiest; Day of Week, Hour of Day, and Beat Territory

for 2012


Calls For Service by Day of Week

DEFINITIONS USED FOR STATISTIC COUNTS

Property Crimes

In the Uniform Crime Reporting (UCR) Program, property crime includes the offenses of burglary, larceny-theft, motor vehicle theft, and arson. The object of the theft-type offenses is the taking of money or property, but there is no force or threat of force against the victims. The property crime category includes arson because the offense involves the destruction of property; however, arson victims may be subjected to force.

Sex offenses

Offenses against chastity, common decency, morals, and the like. Incest, indecent exposure, and statutory rape are included. Attempts, battery and child sex crimes are included.

Forcible rape

The carnal knowledge of a female forcibly and against her will. Rapes by force and attempts or assaults to rape, regardless of the age of the victim, are included. Statutory offenses (no force used—victim under age of consent) are excluded.

Violent Crimes

Violent crime is composed of four offenses: murder and nonnegligent manslaughter, forcible rape, robbery, and aggravated assault. According to the Uniform Crime Reporting (UCR) Proram's definition, violent crimes involve force or threat of force.

Drug Abuse Violations

The violation of laws prohibiting the production, distribution, and/or use of certain controlled substances. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation, or importation of any controlled drug or narcotic substance. Arrests for violations of state and local laws, specifically those relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The following drug categories are specified: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics?manufactured narcotics that can cause true addiction (demerol, methadone); and dangerous nonnarcotic drugs (barbiturates, benzedrine).

Driving under the influence Driving or operating a motor vehicle or common carrier while mentally or physically impaired as the result of consuming an alcoholic beverage or using a drug or narcotic.

Liquor laws The violation of state or local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, or use of alcoholic beverages, not including driving under the influence and drunkenness. Federal violations are excluded.

Drunkenness To drink alcoholic beverages to the extent that one's mental faculties and physical coordination are substantially impaired. Driving under the influence is excluded.
