FY21 Budget Update

Finance Committee Report

The Finance Committee met on 11/13/19 to discuss the FY21 budget. Items discussed were:

- Network switches supported by Frederick County are due to be replaced;
 total cost projected per County IT \$153k; will need added to budget
- No COLA/Merit included in the budget proposed to the Finance Committee, however an estimate was provided for each locality on 2% increase
- After the meeting Mr. Whitley advised :
 - Add in the Network switch cost
 - Had Captains review budget again to make more cuts
 - Overall the budget decreased \$157k from original proposal to Finance Committee

NO MERIT/COLA INCLUDED IN THIS DRAFT

Effective February 16, 2020, Security teams will start permanent day and night shifts. In order to maintain current staffing and help with recruitment (since all new hires will be on permanent night shift), the Captain of Security has proposed a \$1.00 shift differential pay increase to those officers working night shift. Overall cost is \$126,000, which includes fringe. There will be no extra cost in the FY21 budget due to (2) Lt. retiring in late FY20. Cost for FY22 will be added to the budget.
