CPMT Meeting Minutes: Monday December 16th, 2019

The Community Policy and Management Team (CPMT) Committee met on December 16, 2019 at 1:00 p.m. in the first-floor conference room at Frederick County Government Offices Administration Building, 107 North Kent Street, Winchester, VA 22601.

Call to Order: Tamara Green called the meeting to order at 1:03pm.

Adoption of December Agenda: Mark Gleason made a motion to adopt the December agenda as amended; Jay Tibbs seconded; CPMT approved.

Consent Agenda: The following items were put in the Consent Agenda for CPMT's approval:

- November 25th CPMT Minutes
- Budget Request Forms Confidential Under HIPAA.

Adoption of November: Mark Gleason made a motion to approve the November minutes; Jay Tibbs seconded; the CPMT approved.

Adoption of Budget Request Forms: Mark Gleason made a motion to approve the Budget Request Forms; Jay Tibbs seconded; the CPMT approved. Private Provider and Parent Representatives abstain from voting on funding for youth receiving services provided by their respective agency or where there may appear to be a personal financial gain from the provision of services.

Committee Member Announcements:

CSA Report: 2020 Pool Reimbursement: net expenditures were \$1,090,533.40 with a local match of \$442,317.69. November expenditures were \$435,474.21, approximately 13% of the budget. Of the 105-youth served to date, 17 have been in congregate care and 12 in a TFC. The remaining 76 youth have been served in the community.

Non-mandated/Protected Funds Budget: The CSA Coordinator summarized the non-mandated budget stating that \$34,011.00 is allocated annually. For FY20, \$19,479.67 has been spent and \$14,739.50 is currently encumbered.

Special Education Wrap Budget: Frederick County has \$20,905.63 allocated with an additional allocation of \$45,631.63 in SpEd wrap funds. To date, \$39,493.00 has been used and an additional \$85,799.00 is encumbered.

Office Updates:

- High Fidelity WrapAround SOC Grant
 - The current grant year started on October 1, 2019. The goal for the year is 40 cases, the region has 13 cases. Of those, 8 are from Frederick, 2 from Warren, 2 from Winchester City, and 1 from Clarke. The CSA Coordinator reported that 2 more are to be referred soon.

- Families First Prevention Services Integration Model
 - o In November, CPMT discussed the need for a policy and procedure to address the FFPSA roll out. Guidance was provided to localities outlining what processes might look like in models of no integration to high integration levels. CPMT requested more data regarding the number of potential cases that could impact workflow. The CSA Coordinator provided a summary of the FFPSA along with estimates of possible caseload.
 - O CPMT requested for the CSA office to research how a higher integration model would work for Frederick County, as the DSS Director is now leaning towards a higher integration model due to the systems already in place and manpower needed to create the infrastructure that CSA currently uses.

New Business:

- Emergency Funding Policy
 - o Tami has requested the review of the Emergency Funding Policy to determine if any changes are necessary to address reported waitlists. A brief survey of local providers

- found extensive waitlists for psychiatric services; however, outpatient therapy and substance abuse services were not identified as having significant waitlists.
- Mark Gleason brought to the team's attention that current Emergency Funding Policy is written to approve services that are deemed necessary in the event of a crisis or emergency and that certain services (i.e. outpatient therapy) would not be an effective service used in an emergency.
- FCPS Memorandum of Agreement
 - O A student at Grafton requires a 1:1 as identified in his IEP. Grafton is currently unable to provide the service. In order to provide for FAPE, FCPS has agreed to utilize an employee from their current substitute list to provide this service.
 - Mark Gleason made a motion to approve the drafted MOA; Jay Tibbs seconded;
 CPMT approved.

Review Assigned Tasks:

- The CSA Coordinator will make a date for a regional discussion of surveys.
- The CSA Coordinator will research how the high integration model would affect CSA hours/workflow.

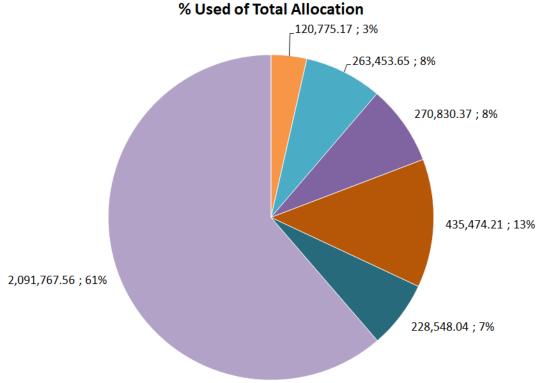

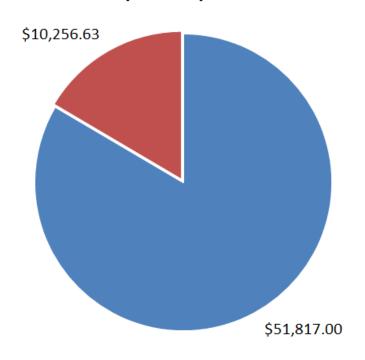

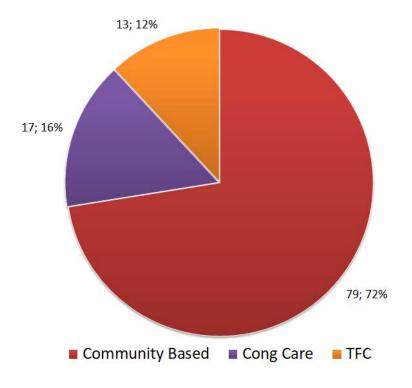

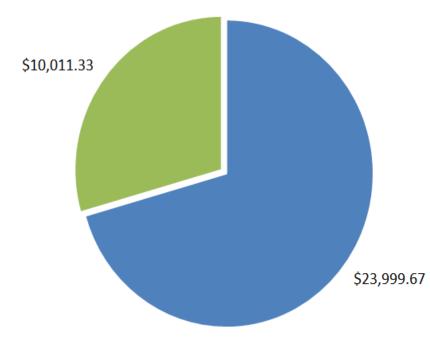

Placement Environment

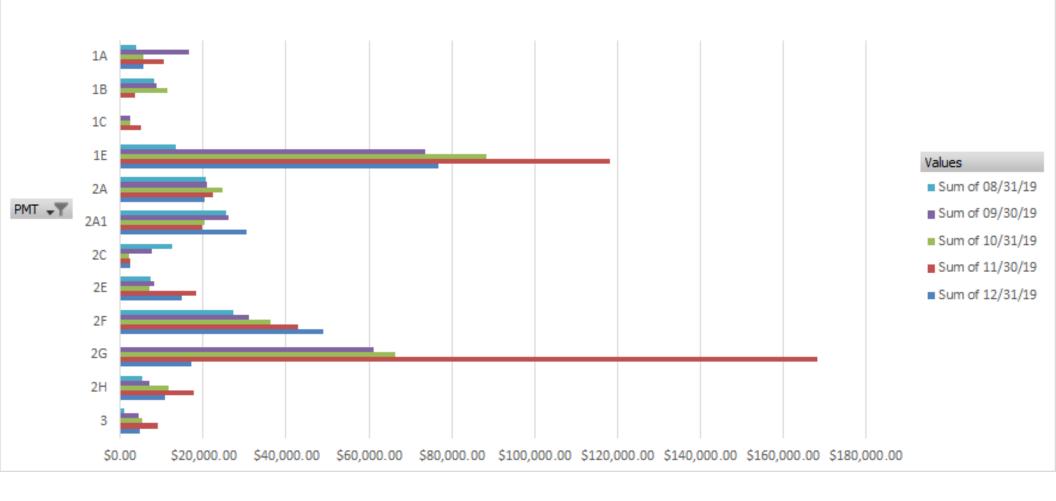


Unduplicated Child Count Served to Date: 109

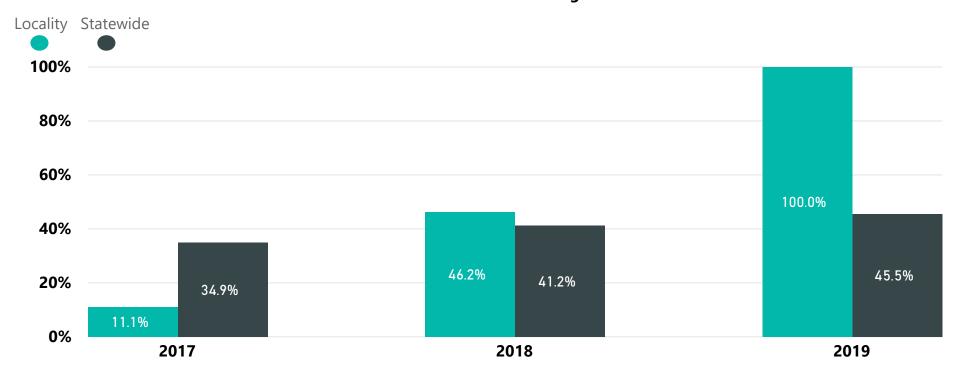

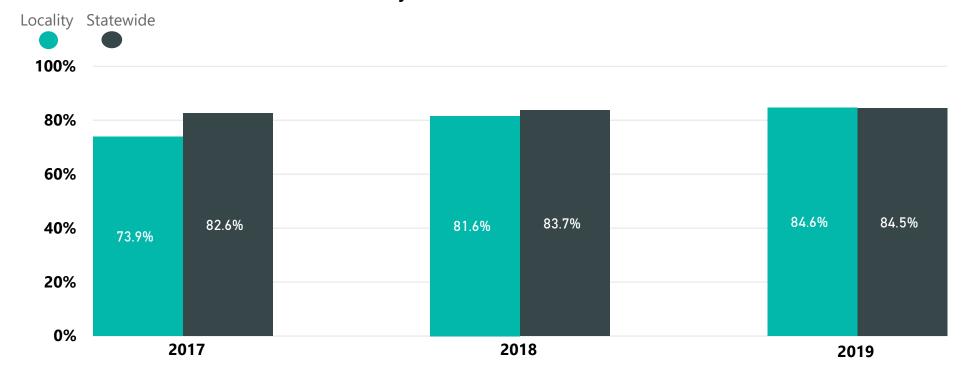

Intensive Care Coordination Target = 75%



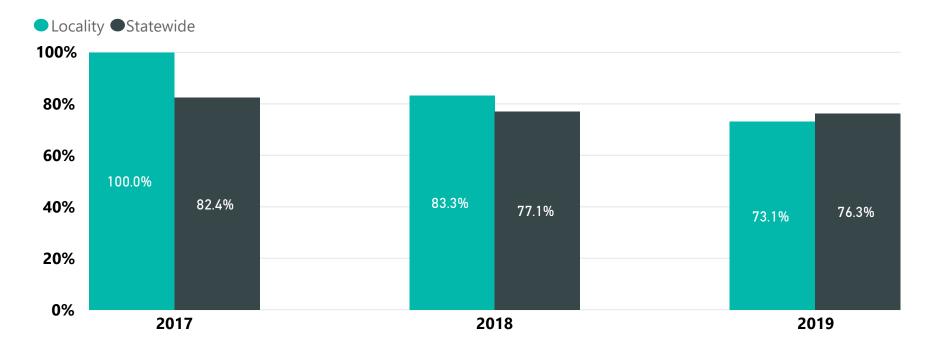
Community-based Services



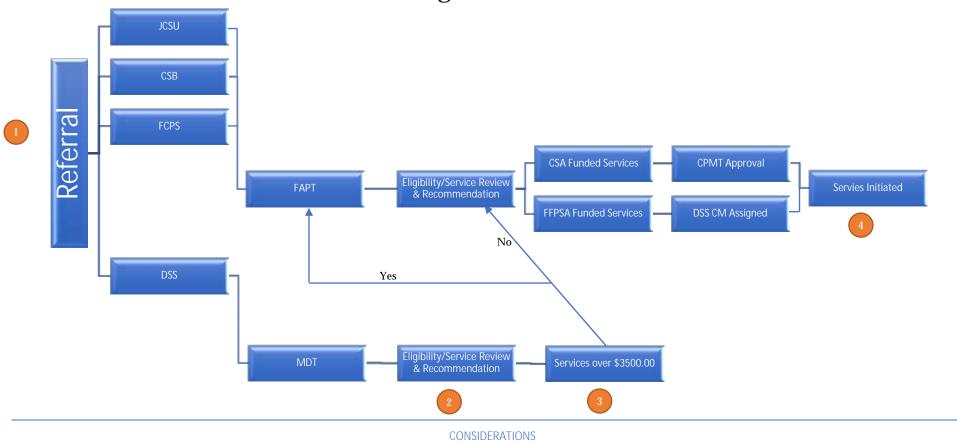
Family-Based Foster Care Target = 85%

Proposed Moderate to High CSA/FFPSA Integration Model



- 1. FFPSA guidelines- FFPSA only funds require review within 30 days. Review for CSA funds uses existing policy- cases scheduled within 4 weeks, unless otherwise agreed to by case manager. Reviews/UR required for FFPSA every 90 days, which aligns with current CPMT policy. Policy allows for use of MDTs.
- 2. High Integration encourages CSA to accept VDSS Prevention Plan format as IFSP to simplify paperwork. VDSS & CSA working to develop a plan that meets both requirements. Collection of additional data points unknown. Local policy to determine alignment of reviews/CANS reviews.
- 3. CPMT would develop policy on whether FFPSA only or combined funds need to be reviewed by FAPT prior to approval/initiation of services. Currently CPMT policy to review funds over \$3500.00/month.
- 4. LDSS can initiate services prior to CPMT funding approval if local policy allows. No copayments for FFPSA services. VDSS continues to discuss vendor contracting, invoicing, and payment process.

Notes: VDSS anticipates guidance to be completed in April. CSA won't be able to finalize integration and policy/procedure until that is available.

Family First Prevention Services Act Frederick County, VA- Summary

PURPOSE:

The Family First Prevention Services Act was signed in as part of Title IV-E of the Social Security Act in October 2018. This legislation expands access to federal funding to eligible youth for the provision of mental health/substance abuse services, regardless of entry into foster care or family household income. Services are meant to prevent youth from entering foster care and prevent disruption of adopted youth.

ELIGIBLITY:

- Meets definition of "child" (as defined in section 475(8) of the Act).
 - o the term "child" means an individual who has not attained 18 years of age
- Meets definition of "candidate for foster care" (as defined in section 473(13) of the Act).
 - o "a child who is identified in a title IV-E prevention plan as being at imminent risk of entering foster care (without regard to whether the child would be eligible for title IV-E foster care maintenance payments, title IV-E adoption assistance or title IV-E kinship guardianship assistance payments), but who can remain safely in the child's home or in a kinship placement as long as the title IV-E prevention services that are necessary to prevent the entry of the child into foster care are provided. A "child who is a candidate for foster care" includes a child whose adoption or guardianship arrangement is at risk of a disruption or dissolution that would result in a foster care placement".
 - § "Imminent Risk" is not further defined by US DHHS.
- Pregnant or parenting youth in foster care
- Parents or kin caregivers where services are needed to prevent the youth from entering foster care

REQUIREMENTS:

Eligible youth must have a DSS written prevention plan which include required components

FLIGIBLE SERVICES:

- Mental Health prevention and treatment
- Substance Abuse prevention and treatment
- In-home parent skill based training

Services must be directly related to the safety, permanence, or wellbeing of the child or preventing the child from coming into foster care.

Services must be provided using a trauma informed or trauma based approach (SAMHSA Guidance).

Services must be approved by the Title IV-E Prevention Services Clearinghouse and rated be as promising, supported, or well-supported. Approved services can be found on the website https://preventionservices.abtsites.com/program.

The provision of services is time limited and may be provided for up to 12 months (with exceptions) from the date the Commonwealth either identifies the youth as a meeting imminent risk or is pregnant or parenting foster youth in need of those services.

The training will be March 17-18, 2020, in the Corron Center at Lord Fairfax Community College. The times for the sessions will be 9:00 a.m.-4:00 p.m., with lunch provided.

In an effort to include community in developing awareness of the impact of trauma on students and how we are working to address this, we have elected to include various community groups and individuals in our training. The goal is to have community representatives seated with school teams to be able to discuss and share ideas and ways the community and our division can work together to address this critical issue.

Note that specific staff positions have been earmarked to attend. There is also an "others" column for you to enter names of additional staff members that you would like to include. Once we have a clear idea of the number of additional staff that schools would like to include, we will let you know if their attendance is possible. Space, substitute availability and funding to support additional attendees will play a role in that decision. Evidence-Based Practice in Virginia:

Are you ready to turn data into wisdom?



As we prepare to move into the next decade, Virginia's child and family serving systems are undergoing dramatic change. Do these phrases ring a bell?

- The Family First Prevention Services Act
- Behavioral Health Redesign
- Juvenile Justice Transformation
- Virginia Tiered Systems of Support
- High Fidelity Wraparound
- System Transformation Excellence and Performance (STEP-VA)

Embracing schools, social services, juvenile justice, behavioral health and CSA systems, all of these initiatives involve the identification and installation of evidence-based practices (EBP) - a wide set of interventions that have established effectiveness in improving outcomes for children, families, and communities.

Becoming a more evidence-based system doesn't "just happen" and will require extensive partnerships and lots of work. If you ever look into the heart of "collaboration" you'll find the word "labor." In the public sector, state agencies and local partners will need to learn together and work together to realize the potential benefits of these changes and to assure they are installed with sensitivity to local and individual youth and family needs.

In recognition of this, representatives of the Commonwealth's child-serving agencies and their local partners (Children's Services Act, Education, Social Services, Juvenile Justice, Behavioral Health and Developmental Services, Medical Assistance Services (Medicaid)) are planning a series of FREE Regional EBP Learning Collaboratives facilitated by the National Implementation Research Network. The purpose of these events is:

To bring together local teams in the children's services system(s) to build leadership capacity, learn about evidence-based practices (EBP), current Virginia EBP initiatives, and to begin/continue local level planning for successful EBP implementation and sustainability.

These events will not focus on specific EBPs, but about getting ready to think about and implement a variety of new practices with youth and families at the locality level.

Localities, or if more practical and appropriate, regional teams of representatives from the child-serving systems (think about for example, the agencies on your CSA teams or who might be a local "agent of change") are invited to come together for a day of learning, self-reflection, team building, and planning to enhance your local/regional readiness for the adoption, implementation and long-term sustainability of the new and excited approaches.













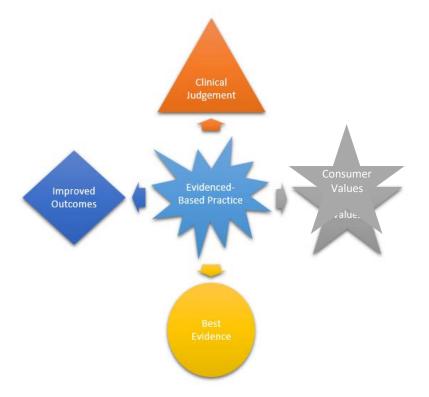


Locality teams would include a single jurisdiction and are most appropriate for larger jurisdictions where agencies only "cover" that locality (e.g., the CSB and the CSU serve only that locality). Regional teams might be most appropriate for a group of smaller or more rural localities, those where the CSU and the CSB are multijurisdictional, or regions where several smaller localities might work with a larger locality in a collaborative approach. Regional teams need not adhere to traditional regional boundaries such as planning districts, DSS region, etc., but rather, should reflect the reality of services on the ground. It may be, for example, that a jurisdiction in one planning district/CSB catchment area is actually closer to and have a history of access to a different jurisdiction/district for the types of services and service providers most relevant to their population.

This free training is open to all localities and will take place in April 2020 in a variety of locations throughout the Commonwealth:

- Northern Virginia April 15
- Richmond April 16
- Abingdon April 23
- Lynchburg April 24
- Tidewater April 30

Local or regional teams should identify their team members and submit the application no later than February 14, 2020. Local/regional teams will receive confirmation of attendance on or before March 13, 2020.
