I. CALL TO ORDER

Mr. Tierney called the meeting to order at 10:00 a.m.

II. APPROVAL OF AGENDA

Mr. Tierney solicited a motion to approve the agenda. A motion was made by Sheriff Millholland to approve the agenda. Ms. McCann-Slaughter seconded the motion. The Authority unanimously approved.

III. APPROVAL OF THE MINUTES FROM THE APRIL, 2019 MEETING

Mr. Tierney solicited a motion to approve the minutes from the October 17, 2019 meeting. A motion was made by Ms. McCann-Slaughter to approve the minutes. The motion was seconded by Mr. Wells. The Authority unanimously approved.

IV. EMPLOYEE OF THE QUARTER

The Authority recognized Officer Brian Robine as the Jail's Fall 2019 Employee of the Quarter.

Mr. Whitley recognized Lt. Steve Heironimus, who retires January 31, 2020, with a challenge coin.

V. ELECTION OF OFFICERS

Ms. McCann-Slaughter recommended the current officers Kris Tierney, Chairman, Chief John Piper, Vice Chairman and James Whitley, Superintendent, Treasurer/Secretary remain the same for 2020. Sheriff Taylor seconded the motion. The Jail Authority unanimously approved all recommendations.

COMMITTEE APPOINTMENTS

Those members currently serving on the Jail Authority Committees will remain on those committees. The following nominations were made by Mr. Tierney to fill the vacancies on the Finance Committee the Construction Committee Judith McCann-Slaughter to replace Eden Freeman as Chair of the Finance Committee and Chris Boies to fill the 2nd vacancy. Chris Boies and Doug Lawrence were nominated to fill the vacancies on the Construction Committee. Mr. Wiley seconded the nominations. The Jail Authority unanimously approved.

VI. FY21 BUDGET UPDATE

Mr. Whitley reported that the Finance Committee met on 11/13/19 to discuss the FY21 budget. The following items were discussed:

- Network switches supported by Frederick County are due to be replaced; total cost projected per County IT is \$153k; this will need to be added to the FY21 budget.
- No COLA/Merit included in the budget proposed to the Finance Committee, however, an estimate was provided for each locality on 2% increase.

After the Finance Committee met, Mr. Whitley instructed staff to add to the FY21 budget the cost of the new switches and attempt to reduce the budget in other areas to absorb the cost. Staff was able to cut an additional \$157k from the original budget proposal presented to the Finance Committee.

Mr. Whitley presented the following chart:

The major differences in personnel costs are as follows:

- Health insurance costs increased by 10% \$250,920
- Increased Over time/Part-time by \$130,000
- Increase in LEOS cost \$95,000

No Merit/COLA included in this draft. When the Finance Committee met, Frederick County had not indicated if we should include a merit or COLA in the FY21 Budget.

The Superintendent reported that effective February 16, 2020, the Security Teams will start permanent day and night shifts. In order to maintain current staffing and help with recruitment (since all new hires will be on permanent night shift), the Captain of Security has proposed a \$1.00 shift differential pay increase to those officers working night shift. Overall cost is \$126,000, which includes fringe. There will be a not extra cost in the FY21 budget due to (2) lieutenants retiring in late FY20. Cost for FY22 will be added to the budget.

Mr. Whitley reported the differences in operating costs are as follows:

- ➤ Increase in Contract nurses \$170,000
- ➤ HVAC Pod 3 Control system upgrade \$73,000
- > Network Switches \$153,000
- > Surveillance Cameras (5 at 16 MP) \$32,000

Decreased costs:

- Anthem (\$25k)
- Office supplies (\$42k computer upgrades from FY20 completed)
- Housekeeping supplies (\$24K0)
- Inmate uniform/apparel (\$20k taken out of Inmate Canteen account)
