• JLARC – Michele Sandy suggested this be discussed at the next meeting due to time constraints of team members and additional information expected from DOE.

New Business:

- Administrative Memorandum #20-12 informs the CSA localities that updated changes will be coming regarding supplemental allocation requests. They requests will be moved to electronic means. Funds will no longer be based on locality Base Match rates, but now utilize Effective Match rates.
- Connected Communities Early Bird Program On November 23rd, 2020, CPMT approved the
 development of a new service to address the needs of a specific CSA youth. Connected
 Communities created the Early Bird program to provide morning support at a rate of \$35 per
 hour.
- FY21 Special Education WrapAround funds have been depleted. A request has been submitted for \$90,000 additional funds.
- OCS sent an email regarding terminology changes and the implementation of CANS by the
 Department of Social Services. DSS is changing the name of Ongoing and Foster Care
 Prevention categories to be called In Home Cases. DSS cases will now be split into
 classifications of In Home Cases and Youth in Foster Care. The CANS is an evidence-based
 tool that VDSS will begin using for all LDSS In Home Cases.











Subject: Review and Reallocation of FY2021 WRAP-Around Services for Students with Disabilities (SPED

Wrap)

For FY 2021, CSA has been provided \$2.2M to support the State's share of Special Education Wraparound (SPED Wrap) expenditures. These funds are allocated to localities at the beginning of each year based on a locality's prior three years expenditures. OCS will be analyzing allocations mid-year and making adjustments based on current year reimbursement activity.

At the end of January a locality's expenditures of the SPED Wrap-Around will be analyzed and the following actions taken:

- a) A locality's SPED Wrap Allocation will be removed, if a locality has not recorded any expenditures/reimbursements in the Local Expenditure and Data Reporting System (LEDRS) in Expenditure Category 2.h (Wrap-Around Services for Students with Disabilities) as of January 31, 2021.
 This will take place effect February 1, 2021.
- b) If your locality's allocation is removed due to a lack of expenditures posted to LEDRS, but you wish to retain all or part of the allocation, a SPED Wrap Request form will need to be submitted for review.
- c) The SPED Wrap form is located on the CSA Web under Resources / Forms, select SPEDWRAP Request Form. https://www.csa.virginia.gov/Resources/Forms.
- d) Please submit a scanned copied of the form with signatures to the OCS Business and Finance Officer, Kristy Wharton (kristy.wharton@csa.virginia.gov).

The use of funds allocated as "WRAP-Around Services for Students with Disabilities" allows communities to provide services to youth when their identified educational disability affects adjustment outside the school environment. Such services may provide critical support for youth who face significant challenges in the home or community. Communities are encouraged to consider their local policies regarding the provision of SPED Wrap-Around services and to identify strategies to maximize utilization of community-based supports for all youth.

e) If your locality requires additional SPED Wrap allocation to support anticipated services for the remainder of FY 2021, please submit a request for additional allocation. OCS will continue to distribute State SPED Wrap funds until the \$2.2M has been fully utilized.

Children's Services Act; eligibility for state pool of funds; pilot program related to educational placement transition for certain students with disabilities. Expands eligibility for use of the state pool of funds under the Children's Services Act to services that are provided in a public school setting and requires that private day schools be approved and licensed by the Department of Education or an equivalent out-of-state licensing agency to be eligible for the state pool of funds. The bill requires the Department of Education and relevant local school boards to develop and implement a pilot program for up to four years in two to eight local school divisions in the Commonwealth. In developing the pilot, the Department is required to partner with the appropriate school board employees in each such local school division to (i) identify the resources, services, and supports required by each student who resides in each such local school division and who is educated in a private school setting pursuant to his Individualized Education Program; (ii) study the feasibility of transitioning each such student from his private school setting to an appropriate public school setting in the local school division and providing the identified resources, services, and supports in such public school setting; and (iii) recommend a process for redirecting federal, state, and local funds, including funds provided pursuant to the Children's Services Act, provided for the education of each such student to the local school division for the purpose of providing the identified resources, services, and supports in the appropriate public school setting. The bill requires the Department of Education to make a report to the Governor, the Senate Committees on Education and Health and Finance and Appropriations, and the House Committees on Education and Appropriations on the findings of each pilot program after two and four years.
