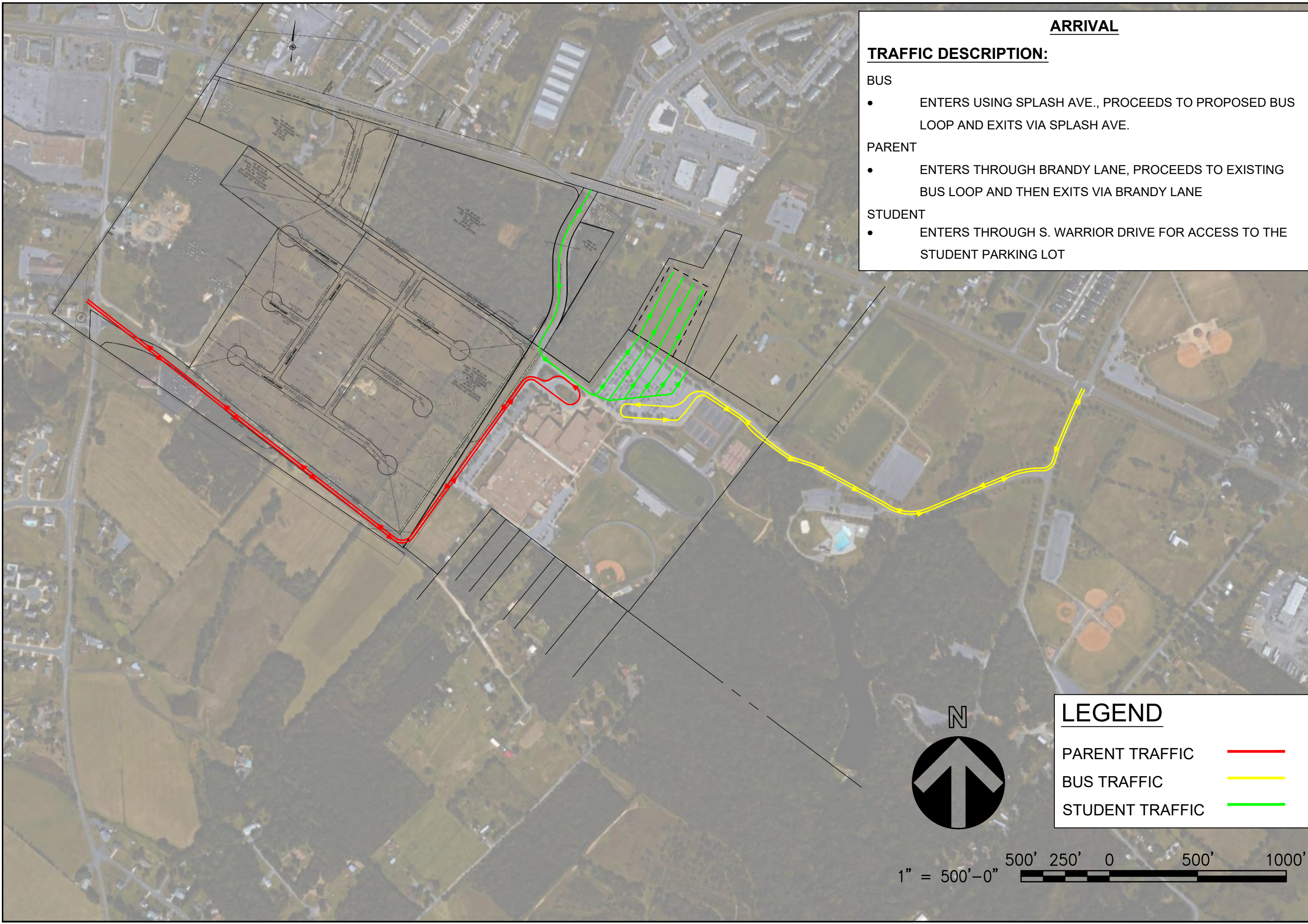

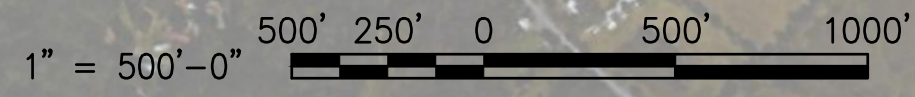

Date: February 23, 2022

Staff is seeking guidance regarding a request from Sherando High School Principal John Nelson to grant full access and control of the recreation center adjacent to the athletic wing of the building and the community center multi-purpose room at Sherando High School. A copy of the request is attached (Attachment 1).

Background:

The community center space at Sherando High School was created with the building of the school, consisting of a multi-purpose room and a separate recreation area with racquetball courts, office space and additional multi-purpose room. The spaces were managed as a community center by FCPRD until March of 2020 when schools were closed at the onset of Covid 19. The community center space reopened in January 2022 for parks and recreation and public use. On July 13, 2021, in response to a request from Sherando HS, the Commission voted (6-0) to allow Sherando HS the use of the multi-purpose room for one academic year to assist with spacing and overcrowding issues.

Staff Recommendation:

Currently the space is being utilized by Parks and Recreation and the public for recreational programs and activities. Staff recommends the request be denied due to the current demand for Parks and Recreation programming and the general public's request to utilize the space. Staff would consider changing its recommendation if an adequate replacement space is provided.


