# TENT INSPECTION CHECKLIST

# **OVERVIEW**

This publication outlines the safety guidelines and permit application requirements related to tents and other membrane structures being used in Frederick County, VA.

A tent is defined as a structure, enclosure, or shelter, with or without sidewalls of drops, constructed of fabric or pliable material supported by any manner except by air or the contents that it protects.

## **PERMIT REQUIREMENTS**

A permit issued by the Frederick County Fire Marshal's Office shall be required for tents greater than 900 square feet or if more than 50 people will occupy the tent.

A permit application can be obtained from the Fire Marshal's Office located at 1080 Coverstone Drive, Winchester, VA or by visiting their website at www.fcva.us/fmo

### INSPECTION REQUIREMENTS

If a permit is being issued by the Frederick County Fire Marshal's Office than an inspection of your tent is required. Please call the Fire Marshal's Office at (540) 665-6350 to schedule an inspection.

The Fire Code Official is authorized to conduct such inspections as deemed necessary to determine the extent of compliance with the provisions of the Code. Vendors shall comply with any applicable Frederick County, VA permits and fees.
