MESSAGE FROM SHERIFF MILLHOLLAND



As the Sheriff of the Frederick County Sheriff's Office, I would like to personally thank you for taking the time to review the Frederick County Sheriff's Office 2021 Annual Report.

The Mission of the Frederick County Sheriff's Office is to provide fair, unbiased law enforcement services to the public, while respecting the individual's constitutional rights.

The Frederick County Sheriff's Office currently has 145 sworn personnel and 10 civilian personnel serving our citizens. This office is a full-service Law Enforcement Agency. This means that we take care of all aspects of Law Enforcement to include but not just limited to Administrative, Patrol, Traffic, Criminal Investigations, Civil Duties (ie Courts and Civil Documents, evictions, levies, mental transports, criminal transports, etc.), Drug Enforcement, Animal Control, School Resource Officers, to name some of our duties. The proud members of the Sheriff Office handled over 84,000 calls for service in 2021. This is about a 3% reduction in the number of calls from 2020. Frederick County has approximately 90,000 citizens who live within the 415 square miles of our county. Shenandoah, Clarke, and Warren County along with the State of West Virginia border this county and create a lot of traffic and visitors.

During 2021, COVID and the Omicron Variant created many issues within our agency as it has the public, and the country. The Sheriff's Office has been fortunate that we only had about 80 personnel who tested positive or were asymptomatic during the pandemic. Many shifts had to be back-filled with personnel from other shifts so there were no breaks in service to the county and our citizens.

Deputies took 5,436 reports pertaining to citizen complaints and arrested 3,472 people that we had direct contact with for violations of the law. Our personnel continue to do their part in trying to prevent drug overdose deaths. There were 66 doses of NARCAN given to 39 people who had overdosed. Four of these people could not be brought back by NARCAN and passed away at the scene.

With the new changes in the drug law, we had to retire 2 of our marijuana/drug detecting K-9's and replace them with K-9's that don't alert on Marijuana. We feel that our K-9's, provide a much needed tool in order to address illegal narcotics in the county.

There are so many different calls for service that Frederick County Sheriff's Deputies deal with every-day. If you review the Group A and Group B offenses in this report, you will see the many types of call for service we respond to.

The Frederick County Sheriff's Office is here to help whenever the need arises and there are issues of public safety that need addressed.

What We Do

Patrol Division

- Deputies patrol the roads and neighborhoods of Frederick County, ensuring safety for our citizens
- Deputies handle criminal responses such as burglaries, animal complaints, traffic related issues, accident
 investigations, business checks, alarm calls, protective orders, detention orders, commitment orders, and
 other misdemeanor and felony related arrests
- Deputies are responsible for case preparation and presenting cases to the Commonwealth attorney.
- Deputies, to include the Traffic Unit, handle a vast array of traffic related issues such as traffic accidents, accident investigations, traffic fatality investigations, traffic complaints, speed enforcement, speed surveys issuance of citations when needed, and other law enforcement duties when required.
- Traffic enforcement continues to increase as the community grows.
- Frederick County Sheriff's Office is a full-service law enforcement agency.

Investigative Division

Handles all major felony cases and the more serious and violent misdemeanor cases, in addition to special
investigations into drug, gangs, child pornography, child sexual abuse, child physical abuse, white collar
crime, and internet crimes against children

School Safety Division

- Provide safety, security, training, law related education for students and faculty of the Frederick County
 Public School System
- Instruct D.A.R.E.
- Teach Civilian Response to Active Shooter Training combined with Stop the Bleed
- Help promote law enforcement friendly community relations with young people by providing programs such as Lunch Buddies, Tribute Tuesdays, Freedom Fridays and Youth Camp.

Court Security/Civil Process

- Responsible for providing security for the Frederick County court rooms
- Serves all civil papers within Frederick County and handling prisoner extraditions and prisoner transports

Administrative Division

- Maintain the Sheriff's Office accreditation, vehicles, uniforms, equipment, training
- Makes policies & procedures, reviews day to day workload

Special Operations Division

- Responsible for all emergency teams and K-9 patrol such as the CNT (Crisis Negotiation Team), CRT (Community Response Team), SWAT (Special Weapon and Tactic), Drone program, DIVE team, Civil Disturbance Team, Search and Rescue Team, Taser training, body camera and a host of others.
- The Special Operation Division is responsible for handling all certification and recertification for the above teams which is required by DCJS.

- Obtain Certification as a Crime Prevention Community from the Department of Criminal Justice Services
- Provide pistol lights and holsters to all sworn personnel
- Send one sworn deputy to the Forensic Academy for training

- Participate in community events
- Obtain one Ballistic Shield for each shift
- Train all personnel in Crisis Intervention Training (CIT)

Code of Ethics



Lifesaving Awards



There are moments when officers walk onto the scene of an incident knowing that they face danger, and yet they still arrive with the intention to save those very same people who threaten to hurt law enforcement. Deputy Quinten Kuhn and Deputy Kyle Russell did just that. Responding to a 911 call in Clearbrook, Virginia, Deputies Kuhn and Russell saved the life of a male who was threatening to injure any arriving officers. The male was observed in the doorway of the residence, bleeding profusely after self-inflicting stab wounds to his neck and chest. The Frederick County Sheriff's Office deputies utilized a towel to apply pressure to the male's injuries until the arrival of Frederick County Fire and Rescue personnel before he was transported to Winchester Medical Center for immediate surgery.

Deputy Kuhn and Deputy Russell were awarded the Lifesaving Award for their actions on January 22, 2021.



Hunter Mundy is known for his big heart and helping others through his non-profit organization, Fallen Riders Inc. He put those words into action one evening after winning a Winchester-based billiards tournament. The runner-up team had come up to congratulate Hunter and his team on their win when one of the teammates fell to the floor and became unresponsive just before midnight. Hunter's wife, Nikki, who works at Winchester Medical Center, cleared the area around the fallen player after checking for a pulse. Hunter began CPR immediately.

Moments later, Deputy David Cullers arrived at the scene. The 65-year-old male was only taking a breath every fifteen to thirty seconds and was in apparent agony. Deputy Cullers took over CPR duties from Mr. Mundy and did so until Frederick County Fire and Rescue arrived. The victim had begun breathing on his own and eventually talking while being transported to Winchester Medical Center for care and testing.

Hunter Mundy was awarded the Citizen's Award and Deputy David Cullers received the Lifesaving Award for their actions on March 4, 2021.



On Friday, March 5th, FCSO was alerted to a possible larceny of power tools from Miller's Ace Hardware in Stephens City. A subject had been observed on a surveillance camera exiting from a side door of the business, at closing time, who appeared to be concealing merchandise that had not been paid for.

The suspect was last seen in a U-Haul truck leaving the parking lot and heading West on Fairfax Pike prior to deputies arriving at the business. While information was being gathered on scene, other deputies were given the description of the U-Haul and located it on Route 50 West and performed a traffic stop. Deputies attempted to identify and speak to the female driver and male passenger and eventually confirmed that this was the vehicle and suspects of the larceny from the business.

Thanks to the efforts of Deputies J.L. Walther, M.J. Porpillia, T.E. Spears and J.A. Tanner working together, from the scene and on the traffic stop, all the stolen power tools and merchandise, with a combined value of over \$3,000, was recovered. Both suspects had warrants out of other states for similar crimes and are currently being held at the adult detention facility on numerous charges related to this crime in Frederick County.

PDEFINITIONS USED FOR STATISTIC COUNTS

Property Crimes

In the Uniform Crime Reporting (UCR) Program, property crime includes the offenses of burglary, larceny-theft, motor vehicle theft, and arson. The object of the theft-type offenses is the taking of money or property, but there is no force or threat of force against the victims. The property crime category includes arson because the offense involves the destruction of property; however, arson victims may be subjected to force.

Sex offenses

Offenses against chastity, common decency, morals, and the like. Incest, indecent exposure, and statutory rape are included. Attempts, battery, and child sex crimes are included.

Forcible rape

The carnal knowledge of a female forcibly and against her will. Rapes by force and attempts or assaults to rape, regardless of the age of the victim, are included. Statutory offenses (no force used—victim underage of consent) are excluded.

Violent Crimes

Violent crime is composed of four offenses: murder and nonnegligent manslaughter, forcible rape, robbery, and aggravated assault. According to the Uniform Crime Reporting (UCR) Proram's definition, violent crimes involve force or threat of force.

Drug Abuse Violations

The violation of laws prohibiting the production, distribution, and/or use of certain controlled substances. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation, or importation of any controlled drug or narcotic substance. Arrests for violations of state and local laws, specifically those relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The following drug categories are specified: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics/manufactured narcotics that can cause true addiction (demerol, methadone); and dangerous nonnarcotic drugs (barbiturates, benzedrine).

Driving under the influence Driving or operating a motor vehicle or common carrier while mentally or physically impaired as the result of consuming an alcoholic beverage or using a drug or narcotic.

Liquor laws the violation of state or local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, or use of alcoholic beverages, not including driving under the influence and drunkenness. Federal violations are excluded.

Drunkenness To drink alcoholic beverages to the extent that one's mental faculties and physical coordination are substantially impaired. Driving under the influence is excluded.


Comp Stat Report 2020 vs. 2021


Beginning in 2021 dispatch began recording 911 Hangups as a Call For Service. The 2020 total was 338, and the 2021 total shows as 4604, an increase of 4,266 (1226% increase). Of the 4602 calls, an officer was only assigned to 406 of these calls. Therefore; 4,198 counts are being added as a CFS though an actual dispatching of an officer is not involved. This count is reflecting in the CFS total. Please be aware when asking dispatch for CFS totals.

Comparison of CFS show a 3% decrease during the time period. Within the decrease of 2,702 CFS, the responses with the largest count differences follow:


