HIGH MILEAGE APPLICATION for MOTORCYCLES ONLY

High mileage applications must be submitted to the Commissioner EACH YEAR. This is pursuant to legislation for motorcycles which was effective July 1, 2022. Applications must be submitted EACH YEAR by NO LATER THAN FEBRUARY 15 for currently-owned motorcycles, and within 60 days of motorcycle purchases occurring after February 15. If you do not meet the deadline for the current year, you may file for qualifying motorcycles the following year.

- If qualified: complete, sign, date, and return this Application to address above with required documentation/supporting evidence.
- A High Mileage Application for Motorcycles MUST BE FILED EACH YEAR to continue to receive a reduction.
