The Buildings and Grounds Committee is scheduled to meet at 10am on Tuesday August 2, 2022 in the 1st Floor Conference Room of the County Admnistration Building, 107 N. Kent St. Winchester, VA 22601. Agenda includes:

Item Requiring Action:

- 1. Recognition of George DiConstanzo at Sherando Park's Field 5
 - George DiConstanzo was an adult softball umpire for Frederick County Parks and Recreation since 1986. George was well known and respected in the softball community for his hard work, humor, and devotion to the softball community. The softball community is asking that Sherando Park Softball Field 5 be named in his honor. As one softball player stated, "you knew every week if you had field 5 on your schedule that you were going to be greeted with a smile and a handshake".

Staff is seeking a recommendation regarding recognition for George DiConstanzo at Sherando Park Field 5.

- 2. Request from Sherando High School to utilize the Sherando High School multi-purpose room for the 2022-2023 school year.
 - Sherando High School is seeking approval to use the multi-purpose room to help alleviate their overcrowding for the 2022-2023 school year. The Commission voted against allowing Sherando HS total usage of the community center, weight room, lobby, and multi-purpose room at the May 2022 meeting. FCPS's request has been modified to include only using the multi-purpose room M-F during school hours and afterschool. FCPRD would have access to the multi-purpose room Friday evenings starting at 6pm through Sunday night at 11pm weekly.
 - Anticipated FCPRD use would not be adversely affected. Primary scheduling of the SHS spaces occurs during the time available per the 22-23 School year modified request.

- 3. Request to place signs along roadways at park locations.
 - The 2 for 2 Foundation has requested permission to place 2 for 2 signs along roadways at park locations. The signs are 18" x 24" and are intended to promote the 2 for 2 foundation.
