Dear Applicant:

Each year, the Frederick County Board of Supervisors reviews requests for amendments to the Comprehensive Plan and initiates those proposed amendments that they feel merit consideration.

Applications for Comprehensive Plan amendment consideration in 2023 must be received in the Planning Department no later than close of business on Thursday June 1, 2023. A copy of the application form is attached. (Please note that while a single application may include multiple parcels, these parcels should be contiguous and be part of the same request).

Please respond in full to those questions that pertain to the particular map, text, or both map and text amendment(s) you are requesting. Incomplete applications will not be considered. Please note that this is not a rezoning application and detailed information, such as floor plans and building elevations, are discouraged.

All applications will be reviewed first by the Comprehensive Plans and Programs Committee (CPPC). Applications will then be considered at a work session of the Board of Supervisors and Planning Commission. Applications deemed to have merit at this work session will be identified for additional study and forwarded to the CPPC for policy development. Subsequently, the application will be sent to the Planning Commission and Board of Supervisors for discussion and potentially public hearing. The Board of Supervisors will ultimately decide whether to accept the Comprehensive Plan amendment application or deny further consideration.

Applicants should consult the Comprehensive Plan to identify goals, policies or action strategies which are applicable to individual Comprehensive Plan amendment requests. A pre-application meeting may be useful to prepare a complete and accurate application. If you would like to request a meeting, or if you have any questions, please contact the Planning Department at (540) 665-5651.
