

Frederick County Sheriff's Office 2012-2013 Goals and Objectives

- Complete the implementation of the Frederick County Sheriff's Office Forward Mobility Project to implement a secure VPN connection between the Sheriff's Office and mobile users. This will be accomplished through the purchase of a NetMotion Wireless Mobility XE software package and compatible server. This increased access will provide for more time in the patrol vehicle, and less time at the office. This will also allow for a safer environment for the Deputies due to their access to critical safety data while in their vehicle and in contact with the public. This software will also allow for necessary updates to be pushed through the NetMotion product without the user having to manually update in person with the information Technologies Section.
- Maintain the Virginia Law Enforcement Accreditation standards set forth for review in 2015.
- Enhance law enforcement and community relations through deputies performing civic duties such as child fingerprinting, Sheriff's Kids Camp, the D.A.R.E. Program, Neighborhood Watch meetings, and updating the Frederick County Sheriff's Office website.
- Reduce traffic related deaths in Frederick County by increasing traffic enforcement efforts on the highways of Frederick County.
- To upgrade current law enforcement equipment with more modern technological advancements. To improve officer and community safety by providing less lethal alternatives to the use of deadly force.
- Increase crime prevention activities in the community. The Sheriff's Office believes one way of reducing crime is through education. This education provides the public with information and suggestion on home, business, and Internet security, as well as personal safety. Local cable channel 16 lists safety tips, current criminal activity or frauds, as well as wanted people.
- To work with County IT to improve security on the maintenance and storage of criminal records as mandated by the FBI Criminal Justice Information audit.
- Work with other County agencies, Board of Supervisors, and citizens of Frederick County to continue to provide the quality of life that our community has come to expect.
- To seek funding sources to provide School Resource Officers in all Frederick County Public Schools.

Task Force, the Regional Gang Task Force, the FBI Violent Crimes Task Force, and the Internet Crimes Against Children (ICAC) Task Force. The Hostage Negotiation Team, the Underwater Search and Recovery Team, and Evidence and Property are also are part of the Criminal Investigation Division.

Sheriff's Office Activities

Frederick County Fair

The Frederick County Sheriff's Office patrols the Frederick County Fair the entire week of the fair. The Sheriff's Office presence at the fair provides a safe environment for everyone attending, so that everyone can have a good time. The fair also provides deputies from the Sheriff's Office and the public an opportunity to interact and develop positive relationships.

Community Relations

Benjamin Smith from Troop #2 of the Boy Scouts of America contacted Sheriff Williamson and asked for our assistance. Benjamin was looking for an Eagle Scout project and wanted to do something for the Frederick County Sheriff's Office. It was decided that a roof would be constructed over the fifty-yard shooting line at the Frederick County Sheriff's Office range. The roof would be sixty feet long and 10 feet wide.

Site preparation and construction required assistance from Sheriff's Office members and community leaders. The project took several months to complete, but the Sheriff's Office now has a nice roof covering the fifty-yard line, and Benjamin Smith is an Eagle Scout.

Frederick County D.A.R.E Program

The Frederick County Sheriff's Office provides the D.A.R.E. program to the 11 elementary schools for Frederick County Public Schools. Almost 1,000 students participated in the D.A.R.E. program in 2012. The Sheriff's Office has received numerous accolades on Deputy Bowers' performance from students, teachers, and school administrators. The Sheriff's Office would like to thank all of the business and individuals who contributed funds to the D.A.R.E. program and Frederick County Public Schools for their continued support of the program.

Frederick County Sheriff's Office Youth Camp

The 15th annual Frederick County Sheriff's Office Youth Camp was a great success. Approximately 80 local children attended and helped with the weeklong camp at Camp Rock Enon. The campers and junior counselors enjoyed repelling, swimming, archery, and several athletic competitions. The Frederick County Sheriff's Office would like to thank the businesses and individuals who support the Youth Camp each year with their donations.

Computer Forensics/Cellular Phone Forensics

Criminal investigations have changed significantly in the 21st century. Over one half of the criminal investigations that are now conducted by the Sheriff's Office involve some type of a computer, I-pad, or cellular phone. Once these items are taken as evidence, a forensic examination has to be completed on the device to determine if the device contains evidence, and then recover the evidence. The evidence may be emails, text messages, photographs, videos, etc.

Investigators Tim Juergens and Bryce Davis completed numerous forensic computer examination courses in 2013. They received certification in CompTIA A+ and Access Data's ACE. They have already completed forensic examinations on 10 computers. Investigators Juergens and Davis

Investigators Juergens, Davis, Swartz, and Galbreath are trained to do forensic examinations on cellular phones. The Sheriff's Office conducted almost 200 forensic examinations on cellular phones in 2013.

High Profile Criminal Case

In August 2011 the Sheriff's Office started receiving complaints of animal cruelty against Russ Ebersole, the owner of Aberdeen Acres. Aberdeen Acres provides obedience training and for dogs. The numerous complaints were from former employees and dog owners who had taken their dogs there to be obedience trained.

The Sheriff's Office began an extensive investigation that included interviewing numerous victims and witnesses. A search warrant was executed on the business were numerous articles of evidence was recovered. A forensic examination was done on the business's computers by the United States Secret Service. The investigation resulted in Mr. Ebersole being charged with 14 counts of Animal Cruelty in November of 2012.

There were numerous continuances in the court case after the charges were placed. During this period Mr. Ebersole was charged with another count of Animal Cruelty in August of 2013. Finally in October of 2013 Mr. Ebersole agreed to plead guilty to 4 counts of Animal Cruelty in a plea agreement. Mr. Ebersole was sentenced to 2 years in jail, 4 years probation, a \$10,000 fine, and he cannot process companion animals for 4 years.




Busiest; Day of Week, Hour of Day, and Beat Territory

for 2013


Calls For Service by Day of Week

Agency: FCSO Date: 01/01/2013 - 12/31/2013




Calls by Law Beat



DEFINITIONS USED FOR STATISTIC COUNTS

Property Crimes

In the Uniform Crime Reporting (UCR) Program, property crime includes the offenses of burglary, larceny-theft, motor vehicle theft, and arson. The object of the theft-type offenses is the taking of money or property, but there is no force or threat of force against the victims. The property crime category includes arson because the offense involves the destruction of property; however, arson victims may be subjected to force.

Sex offenses

Offenses against chastity, common decency, morals, and the like. Incest, indecent exposure, and statutory rape are included. Attempts, battery and child sex crimes are included.

Forcible rape

The carnal knowledge of a female forcibly and against her will. Rapes by force and attempts or assaults to rape, regardless of the age of the victim, are included. Statutory offenses (no force used—victim under age of consent) are excluded.

Violent Crimes

Violent crime is composed of four offenses: murder and nonnegligent manslaughter, forcible rape, robbery, and aggravated assault. According to the Uniform Crime Reporting (UCR) Proram's definition, violent crimes involve force or threat of force.

Drug Abuse Violations

The violation of laws prohibiting the production, distribution, and/or use of certain controlled substances. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation, or importation of any controlled drug or narcotic substance. Arrests for violations of state and local laws, specifically those relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The following drug categories are specified: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics?manufactured narcotics that can cause true addiction (demerol, methadone); and dangerous nonnarcotic drugs (barbiturates, benzedrine).

Driving under the influence Driving or operating a motor vehicle or common carrier while mentally or physically impaired as the result of consuming an alcoholic beverage or using a drug or narcotic.

Liquor laws The violation of state or local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, or use of alcoholic beverages, not including driving under the influence and drunkenness. Federal violations are excluded.

Drunkenness To drink alcoholic beverages to the extent that one's mental faculties and physical coordination are substantially impaired. Driving under the influence is excluded.
