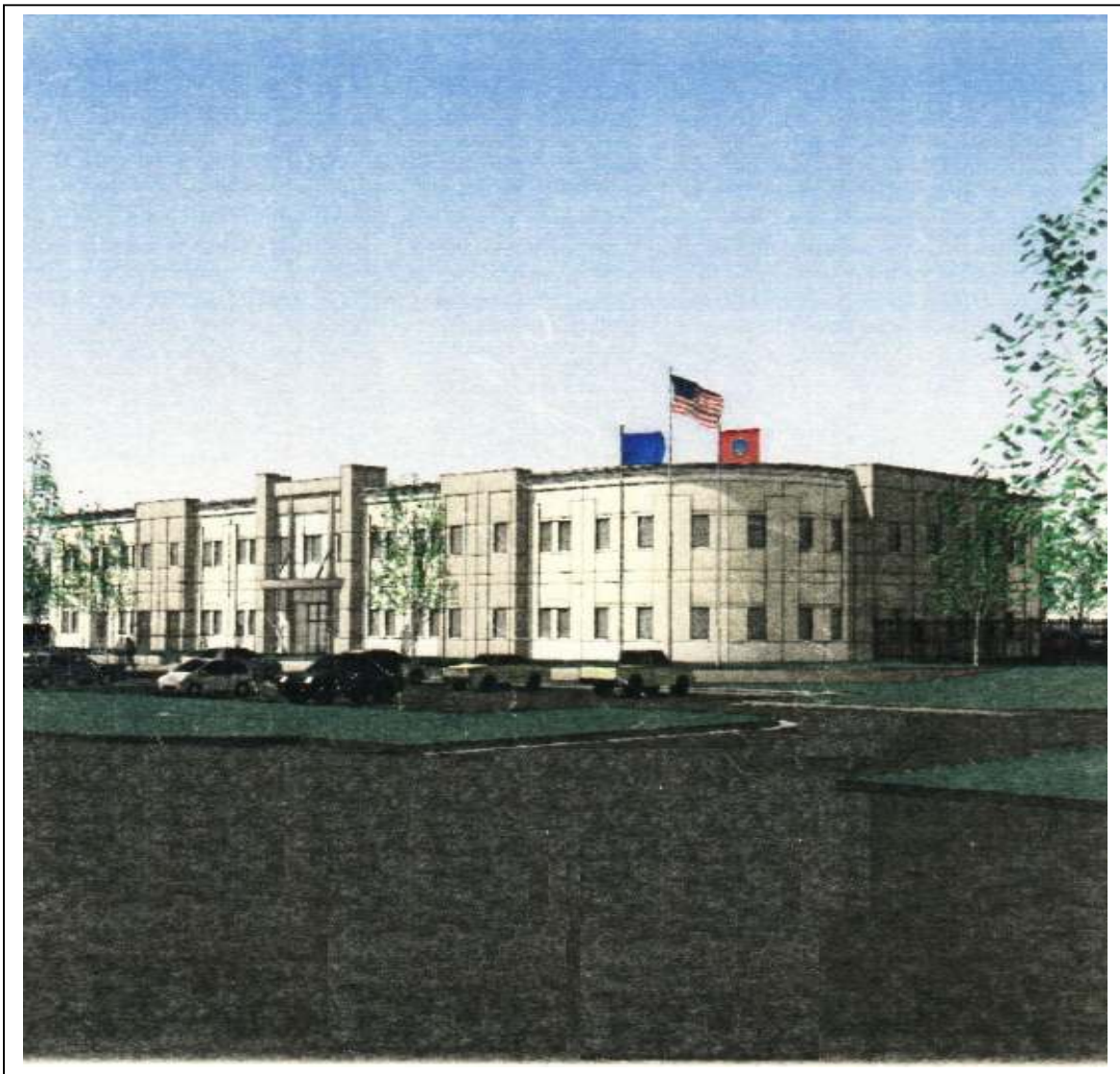

Frederick County Sheriff's Office

2007 Activities

The year 2007 was a momentous year for the Frederick County Sheriff's Office. However, the highlight of the year for the Sheriff's Office was the move to the new public safety building at 1080 Coverstone Drive. The Sheriff's Office had been housed in the Joint Judicial Center at 5 North Kent Street since 1984. The Joint Judicial Center provided adequate facilities for the Sheriff's Office for many years, but the recent growth of Frederick County and the Sheriff's Office required the Sheriff's Office to seek a more modern, spacious facility. The following are some significant events/activities for the Frederick County Sheriff's Office in the year 2007.

Public Safety Building

The Frederick County Sheriff's Office moved into the new public safety building in May of 2007. The new building, with the needed additional space, provided many new opportunities for the Sheriff's Office. The Frederick County Sheriff's Office has since used the new community room to host several law enforcement training classes and regional law enforcement meetings.

The ancillary building contains a forensic garage and laboratory. Both of these have been used for processing evidence in several major crimes. The ancillary building also contains storage areas for the K-9 deputies, the bicycle patrol, the dive team, the Emergency Response Team, and an armory to store ammunition and weapons.

The Frederick County Sheriff's Office is extremely proud of the public safety building and wishes to thank the citizens of Frederick County and the Frederick County Board of Supervisors for the new building and the support they have given the Sheriff's Office in 2007.

Honor Guard

The Frederick County Sheriff's Office formed an honor guard in 2007. There are 10 deputies who volunteered to be on the honor guard. After intensive training, the honor guard has participated in several parades in the area and has assisted with several funerals of Sheriff's Office employees.

Digital Cameras

The Frederick County Sheriff's Office purchased digital cameras for the deputies in 2007. The digital cameras will allow deputies to view their photographs at the crime

scene and retake the photograph, if needed. The photographs are then stored on disks in the evidence room. The digital cameras also make it easier for deputies to share criminal information within the Sheriff's Office, and with outside agencies via the Internet.

Weapons

The Frederick County Sheriff's Office purchased new M-4 patrol rifles for the patrol division in 2007. One of the major changes in weaponry for law enforcement agencies in the 21st Century is the phasing out of the shotgun and implementing the patrol rifle. The Sheriff's Office purchased 65 Smith & Wesson M&P-15A tactical rifles for the patrol deputies and school resource officers to carry on duty. All of the deputies that were issued the new patrol rifles were provided training and qualified with the new weapons.

Apple Blossom

The Frederick County Sheriff's Office provides law enforcement assistance to the Apple Blossom Festival every year. In 2007 the Sheriff's Office again provided security for visiting celebrities, dignitaries, and the festival queen and her court. The Sheriff's Office also handles an increase in calls for service during the Apple Blossom Festival.

Intelligence Meetings

The Frederick County Sheriff's Office has begun attending and hosting the Quad State INTEL meetings. Investigators from law enforcement agencies in Pennsylvania, Maryland, Virginia, and West Virginia meet bimonthly to discuss open cases. This information sharing has resulted in numerous cases being solved in several different states and has increased communication and cooperation between all of the involved agencies.

Frederick County Fair

The Frederick County Sheriff's Office provides foot patrol for the Frederick County Fair the entire week of the fair. The Sheriff's Office presence at the fair provides a safe environment for everyone attending, so that everyone can have a good time. The fair also provides deputies from the Sheriff's Office and the public an opportunity to interact and develop positive relationships.

Frederick County Sheriff's Office Youth Camp

The Frederick County Sheriff's Office sponsored the 10th Annual Frederick County Sheriff's Office Youth Camp at Camp Rock Enon in 2007. Personnel from the Sheriff's Office and sixty-five 11-13 year old youths spent a week together having fun at Camp Rock Enon. The Frederick County Sheriff's Office Youth Camp is a 501 (c) non-profit organization that provides the weeklong camping experience to the children for free. Camp activities for the children include rock climbing, canoeing, swimming, fishing, nature walks, sporting events, and plenty of food.

“Operation Boomerang”

The Frederick County Sheriff's Office assigns deputies to the regional Drug Task Force. In 2007 the Drug Task Force concluded a 13 month long investigation of a major cocaine operation. The Frederick County Sheriff's Office provided additional deputies and its Emergency Response Team to assist the Drug Task Force in conducting search warrants and arresting suspects. Ten search warrants were executed, over twenty people were arrested, and 5 kilograms of cocaine were seized along with thousands of dollars and several weapons.

FBI Violent Crime Task Force

The local FBI field office in conjunction local law enforcement agencies started a violent crime task force. All of the involved agencies assigned a member from their agency to the task force, which will work local violent crimes in the Winchester City-Frederick County area. The local FBI office is providing some of the funding for this task force.

Internet Crimes Against Children

Investigators from the Frederick County Sheriff's Office received training in Internet crimes against children. Then, in conjunction with the Virginia State Police and local law enforcement agencies, a Northern Virginia/DC Internet Crimes Against Children (ICAC) task force was formed. Investigators from the involved agencies go on-line to search for child predators in chat rooms and other areas. The task force has made several arrests in the area since its inception in 2007.

“Allied Waste (BFI) Case”

The Frederick County Sheriff's Office concluded a fraud investigation, which lasted two years, against Allied Waste where Frederick County was the victim of fraud. Although there were no criminal charges placed against officials from Allied Waste, they agreed to pay Frederick County two million dollars in restitution. Investigators from the

Sheriff's Office spent hundreds of hours conducting surveillance on Allied Waste vehicles and sorting through over two hundred boxes of documents for evidence.

Community Presentations

In 2007 the Frederick County Sheriff's Office participated in over 50 community events. These events included child fingerprinting and safety presentations, Neighborhood Watch Meetings, Frauds against Senior Citizen presentations, and presentations to Boy and Girl Scout troops. The Sheriff's Office understands how important community involvement is and deputies are constantly seeking opportunities to build new relationships.

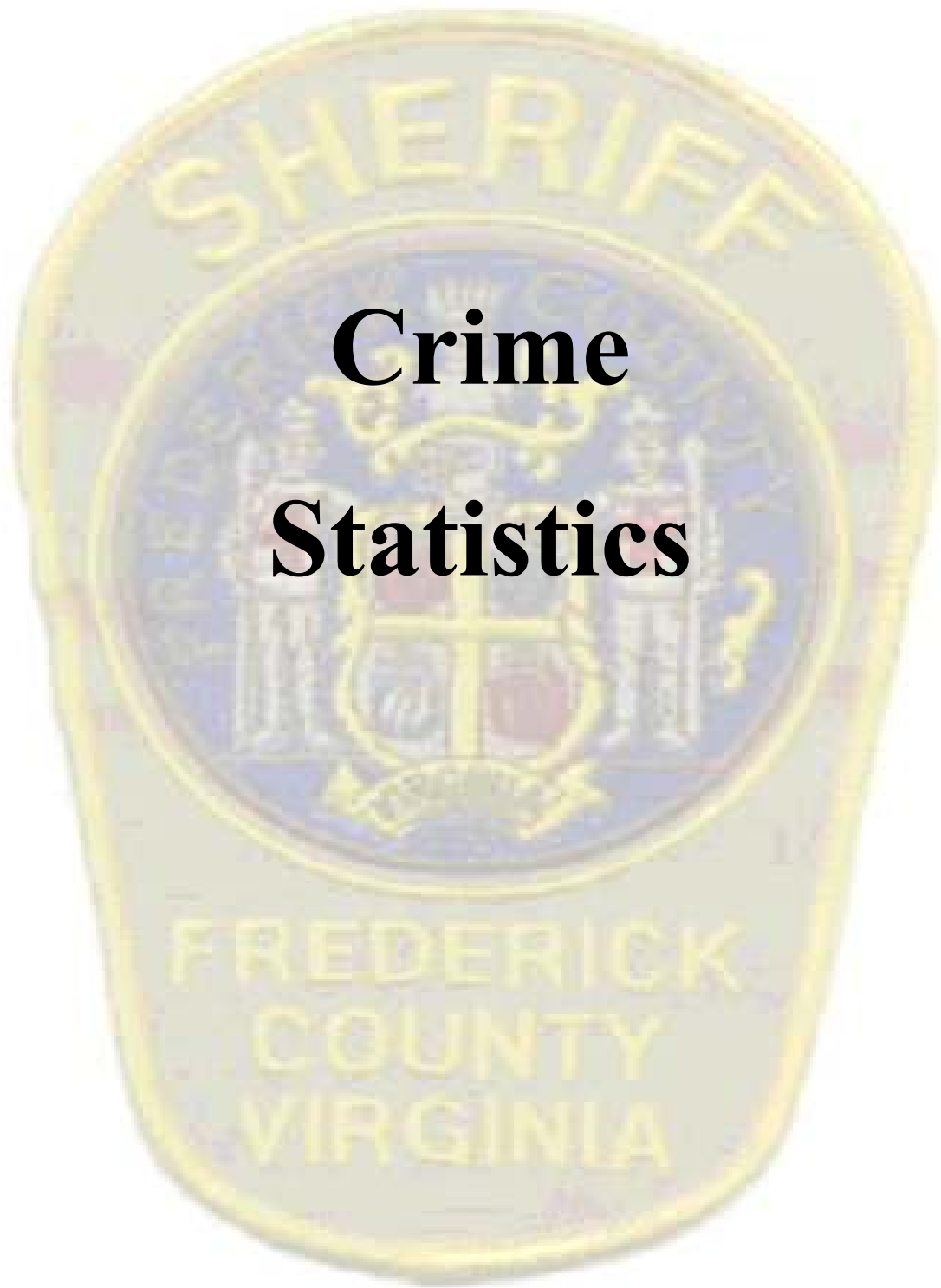
Recognition

In 2007 members of the Frederick County Sheriff's Office were recognized by community organizations for outstanding performance of their duties. In October 2006 Frederick County experienced a heinous crime where four family members were murdered. The Frederick County Sheriff's Office investigated the crime and charged a subject with four counts of murder.

The Winchester Exchange Club recognized the Frederick County Sheriff's Office Emergency Response Team for their capture of the armed suspect. This was the first time the Winchester Exchange Club had ever picked a team as the Outstanding Law Enforcement Officer of the Year. Members of the Emergency Response Team receiving the recognition were: Captain Aleck Beeman, 1st Lieutenant Rick Singhas, Sgt. Jason Cornwell, Deputies Barry Kittoe, Keith Covert, AJ Williams, Bryce Davis, Doug Sardelis, Chris Hockman, Investigator Chris Brown, and Frederick County Fire Marshals Denny Linaburg and Jay Bauserman.

The Winchester Optimist Club selected Captain John Heflin as its Law Enforcement Officer of the year for his leadership role in the investigation of the quadruple homicide. Captain Heflin is the division commander of the Sheriff's Office Criminal Investigation Division.

Finally in 2007, Mothers Against Drunk Driving (MADD) recognized Deputy Donald Garcia for his efforts to reduce drunk driving in Frederick County. Deputy Garcia vigilantly patrols Frederick County locating and removing intoxicated drivers from the highways.

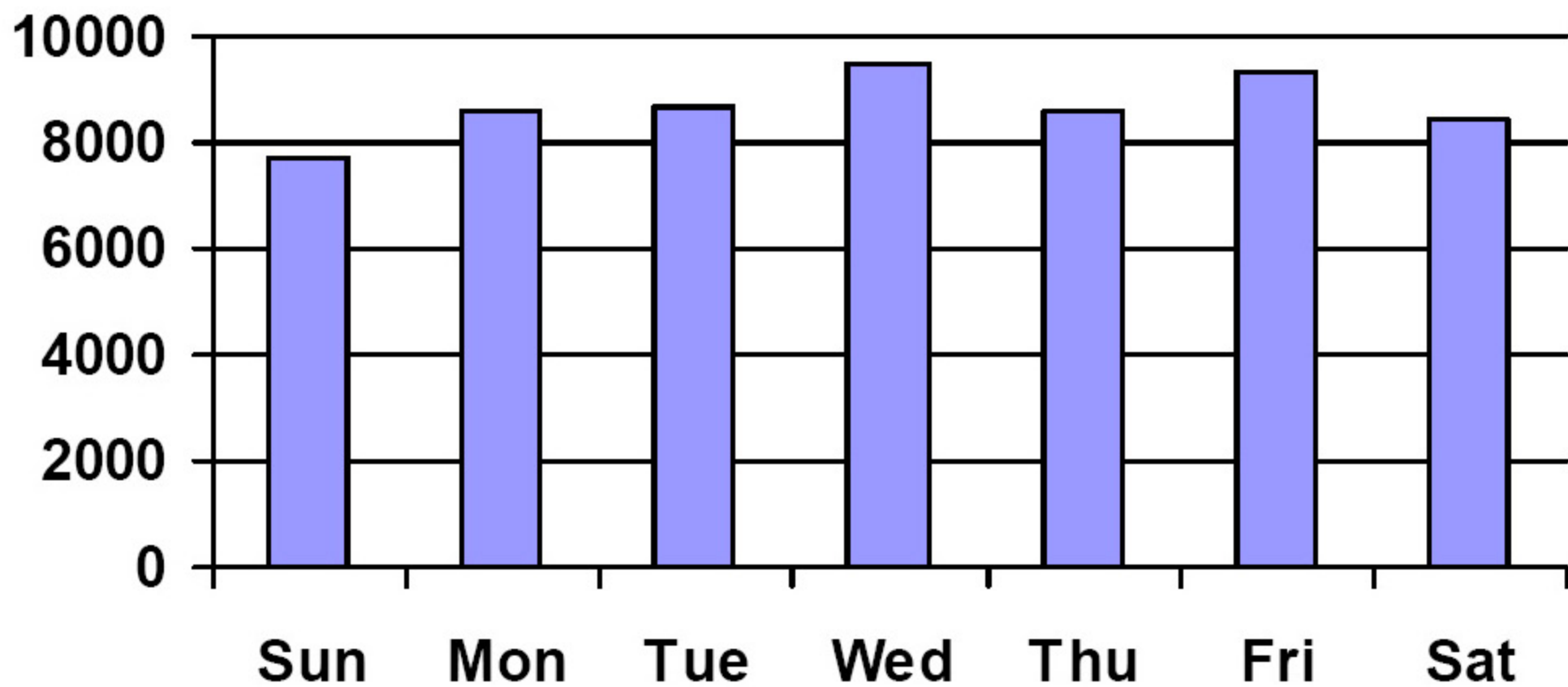

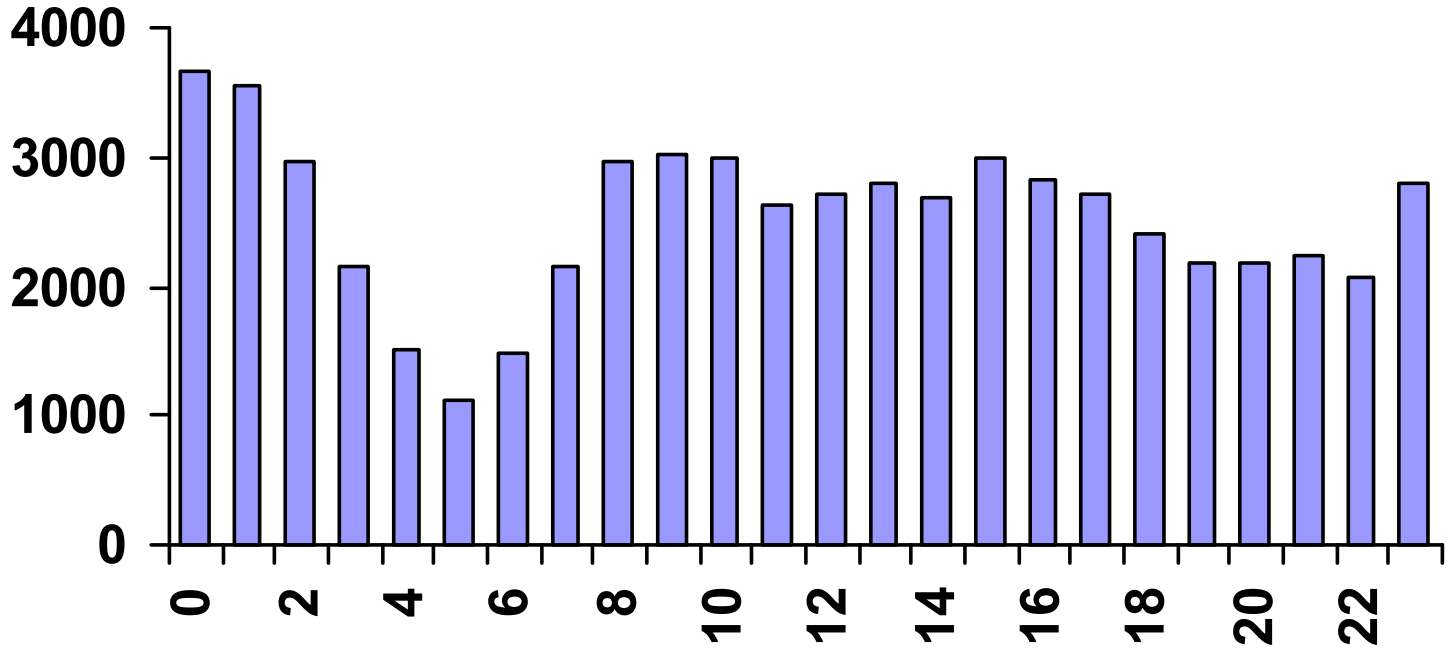

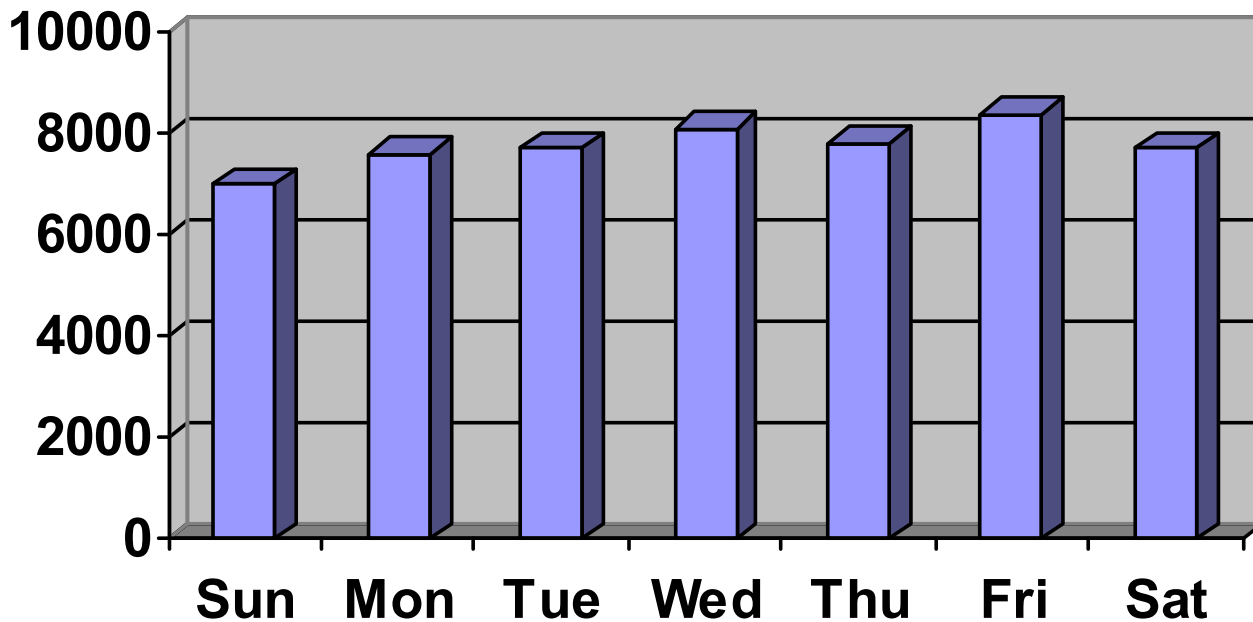

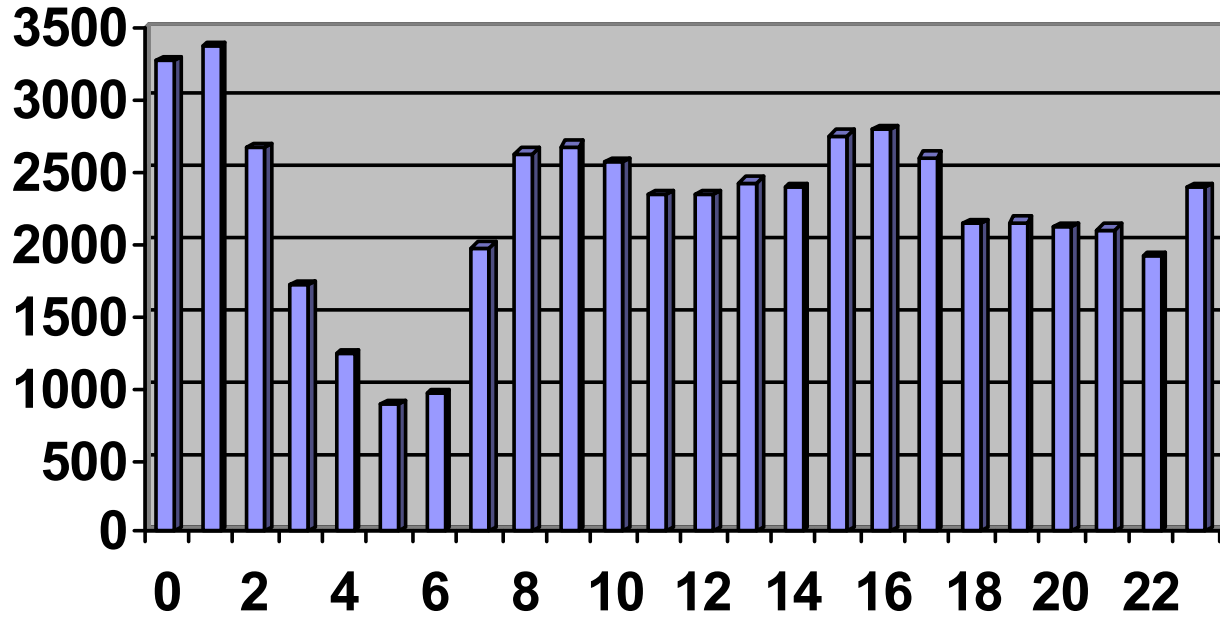
