Per Chapter 155, Article VIII, § 155-34 of the Frederick County Code: A monthly tax is imposed and levied on each purchase of electricity delivered to consumers by a service provider, classified as determined by such provider. The service provider shall bill the electricity consumer tax to all users who are subject to the tax and to whom it delivers electricity and shall report the same to the Commissioner of the Revenue (COR) on a monthly basis. Such taxes shall be paid by the service provider to the Treasurer in accordance with §§ 58.1-3814 and 58.1-2901 of the Code of Virginia. Any tax paid by the consumer to the service provider shall be deemed to be held in trust by such provider until remitted to COR. Such remittance shall be done before the last day of the calendar month following the month the tax was received by the service provider. (See Frederick County Code § 155-34 and Virginia Code § 58.1-2900 et seq. for additional rate and other information.)
