**SUBJECT:** Finance Committee Reports and Recommendations

The Finance Committee met in the Board of Supervisors' Meeting Room at 107 North Kent Street on Wednesday, January 17, 2007 at 8:00 a.m. Members Richie Wilkins and Gary Lofton were absent.

- 1. The Solid Waste Manager requests a General Fund supplemental appropriation in the amount of \$100. This amount represents a donation for the dedication ceremony and open house at the new citizens' convenience center. No local funds needed. See attached memo, p. 1. The committee recommends approval.
- 2. The Parks and Recreation Director requests a <u>General Fund supplemental</u> appropriation in the amount of \$1,846.45. This represents proceeds from the Thanksgiving 5K to be paid to Big Brothers/Big Sisters. No local funds needed. See attached memo, p. 2. The committee recommends approval.
- 3. The Parks and Recreation Director requests a <u>General Fund supplemental</u> appropriation in the amount of \$3,000. This represents a portion of the proceeds from the Winter Wonderland Walking Tour to be paid to WINC Chain of Checks. No local funds needed. See attached memo, p. 2. The committee recommends approval.

- 4. The Fire and Rescue Director requests a <u>General Fund supplemental appropriation in</u> the amount of \$46,802. This amount represents FY05 State Homeland Security grant funds. No local funds needed. See attached memo, p. 3. The committee recommends approval.
- 5. The Director of IT requests a <u>General Fund budget transfer of \$11,200 from an</u> unfilled personnel line item to purchase a server. See attached memo, p. 4. The committee recommends approval.
- 6. The Finance Director requests discussion on changing the capitalization threshold to \$5,000 at the suggestion of the auditors. The committee recommends approval and defers to the Board of Supervisors for final consent.
