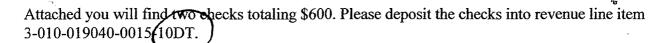

Per your request, Triad Engineering is pleased to provide you with a cost proposal to conduct a lead containing paint survey of the old Gainesboro Elementary School located in Gainesboro, Virginia. The survey will be conducted by a Commonwealth of Virginia licensed lead paint inspector.

SCOPE OF WORK

Triad will conduct the lead based paint survey of the interior and exterior of the building to generally identify building components coated with lead to provide contractors with general information regarding lead-containing surface coatings within the building. The lead-based paint survey will be conducted in general accordance with the procedures and directives described in the *Virginia Lead-Based Paint Activities Regulations*, Commonwealth of Virginia Title 54.1 Chapter 5 as codified in the Commonwealth of Virginia Annotated Code (18 VAC 15-30).

A visual inspection of the surveyed area will be conducted by a Commonwealth of Virginia licensed inspector to determine representative areas which are visually similar in color, texture, general appearance, and which appear to have been installed at the same time. The assessment will include a visual survey of the painted surfaces of interior and exterior components which are accessible and/or exposed.

Sampling locations will be chosen randomly to be representative of the homogeneous painted areas. Where possible, based on random sample locations, samples will be taken preferentially from already distressed painted surfaces. In-place field screening for lead-based paint will be performed by X-ray fluorescence (XRF) field testing. If the XFR provides an inconclusive measurement, a paint chip of the surface area will be collected and submitted to an accredited laboratory for analysis.

Our report will provide general recommendations concerning appropriate response actions for those materials that are found to contain lead paint.

The report will be prepared in accordance with generally accepted environmental practices and industry standards and will not include any services that are not specifically defined in this proposal.

During a regularly scheduled meeting on May 27, 2008, the public works committee reviewed and unanimously endorsed the following supplemental appropriation requests:

- 1. Old Gainesboro School: The committee endorsed an amount of \$151,800 to correct deficiencies at the old school building as well as add fire alarm and security systems. This cost estimate was derived from a building evaluation performed by OWPR, Inc. A majority of the remedial repairs will be associated with the existing roof system which is currently leaking in several areas. At this time, the funds shall be placed in the maintenance and grounds budget line item 10-4304-3004-07 Repair and Maintenance Buildings and Grounds Gainesboro School. A request to establish a capital asset line item to encumber funds for the necessary repairs will be made at a later date. (Attachment 1)
- 2. Shawneeland Dam: The committee endorsed a request from the Shawneeland Sanitary District (SSD) Advisory Committee to proceed with the grouting of the foundation under the Lake Cherokee dam to repair leaks and prevent further deterioration of the foundation materials. Staff has estimated the cost of these repairs at approximately \$500,000. Consequently, we are requesting a supplemental appropriation in this amount derived from the SSD reserve account. The funds shall be placed in the SSD budget line item 16-8108-8900-00 Improvements Other Than Buildings. (Attachment 2)

During our last meeting held on April 29, 2008, the committee reviewed and endorsed an expenditure not to exceed \$3,000 to perform a lead paint study and to test the built-up roof for asbestos. Because the finance committee meeting scheduled for May 21, 2008, was cancelled, this request will be included in their June agenda.

We are recommending that the costs for "moth balling" the school also be included with the above request. The committee reviewed these costs in conjunction with discussing the contents of the OWPR report dated March 19, 2008, which described the existing deficiencies and recommended corrective action. The committee recommended that the corrective action be limited to fixing the roof system and adding the fire alarm and security systems. These two systems combined will cost \$17,000. The roof repairs/maintenance is estimated at \$121,000. Including a ten (10) percent contingency factor would result in a total estimated cost of \$151,800.

We are requesting the committee's endorsement to submit this amount to the finance committee for their consideration.

Grouting Lake Cherokee Dam

During the past year Shawneeland property owners have been confronted with major repairs to stop water leakage from Lake Cherokee. The county hired Triad Engineering to conduct a series of subsurface studies. The conclusion of their studies was that water was seeping through fissures in the limestone under the lake. The County Engineers believe that installing a grout curtain under the dam area has a very good chance of stopping the leakage. The grouting would extend at least 100 feet below the base of the dam.

The cost of this project was estimated to be between \$400,000 and \$500,000. It was such a large expenditure that we felt it was necessary to survey all of the tax paying property owners to see if they wanted us to proceed with the repairs. Your office prepared labels for the survey, mailed surveys to owners, collected the returns and tallied the results. The owners voted overwhelmingly to make the repairs. The final count was 302 favoring making repairs to 89 opposed. This is a strong mandate from the owners with more than three out of four owners responding in favor of making the repairs.

The SSDAC requests that the County authorize expenditure from the Sanitary District reserve fund to repair the lake up to a limit of \$500,000.

The Federal funds received in the amount of \$74,000.00 represent reimbursement for the purchase of portable radios/equipment and Dell Laptop computers. The radios were requested and purchased under Purchase Order #20700 and the computers were on Purchase Order #20667.

We are requesting these funds be appropriated into the operating budget for this department as follows:

1) \$64,000 appropriated into Central Stores-Gasoline, 4003-002

2) \$10,000 appropriated into Professional Services – Other, 3002-000

Justification for 1: We currently have a deficient of \$11,194.12 (as of 5/12/08) in gasoline charges. In looking at our spending level for gasoline, we estimate that we will purchase approximately \$67,127 through the end of June 2008. We are requesting \$64,000 of the Federal grant funds to be appropriated into our operating line for gasoline to cover current deficient and to cover additional expenditures in this line.

Justification for 2: We have been notified that we must conduct a "stack test" on the incinerator before it is put into operation. This is a mandatory test that we were not aware of when requesting operating funds in our current budget therefore we are requesting \$10,000 of the Federal grant funds be appropriated into our operating budget to cover this test. We are in the process of obtaining price quotes regarding this test and the only one we have received to date is in the amount of \$8,900.00

Any consideration in these requests would be greatly appreciated.

Dear Mr. Riley:

During the last legislative session the legislature amended the statute to allow localities to supplement the district courts for personnel. While the circuit courts have had this ability for many years, this is a first for both the Juvenile and Domestic Relations and General District courts. At this time Frederick County provides both salary supplements and personnel allocations for the Circuit Court.

Currently the Juvenile and Domestic Relations Court for our locality is understaffed by three full time positions and the General District is understaffed by two full time positions. These figures are based on 2006 caseload statistics and do not incorporate the 2007 statistics. With the evergrowing population as well as increases in the number of law enforcement officers, prosecutors and others in the legal field, we find ourselves and our staff at a point where we must ask for local assistance.

We are asking that each of our courts be granted a supplement of \$7,000.00 to be used for personnel. This amount is much less than the amount currently allotted to the Frederick County Circuit Court for the same purpose. It would be a tremendous asset to both of our courts as well as the citizens and other agencies we serve.

We ask your consideration of this request, which would be the first allocation of this nature for the district courts in our 40-year history. Please feel free to contact us if we can provide further information for you. We have kept our request brief however we are glad to produce any supplement information you may need.

The Parks and Recreation Department's proposed FY 2009 spending plan offers an 82 cent return on each dollar spent on recreation programs. This includes 100% return on all direct costs and an additional \$40,634 covering indirect expenditures associated with the Recreation Division. After contacting a professional consulting firm specializing in analyzing the operation of parks and recreation departments, it is apparent that this department's return on dollars spent on recreational programs ranks high nationally. Considering we are limited due to the small number of revenue generating facilities under our direction, an 82 cent return on the dollar becomes even more significant. Additionally, the last four fiscal years indicate that the actual return on the dollar for the Recreation Division is an average of 6.5 cents higher than projected in our appropriated budgets.

Please find attached a summary of recreational program revenues and expenditures. We have included the across the board impact of a 13%, 20% and 26% increase in program fees. A 26% increase would be needed to recoup all Recreation Division direct and indirect cost. To illustrate the impact of a 26% increase, a family with children in the before and after school programs would pay an additional \$839 annually for each child registered.

Although our activities are very well received, we believe there is a price point which will turn customers away. When developing our programs we are very conscious of this and include in the activities only that for which we believe the consumer will be willing to pay while still offering a quality experience. In short, we believe increasing program fees will result in a decrease in participation and revenue. Furthermore, the need for affordable close to home leisure opportunities is becoming more critical. To price local recreational opportunities out of the reach of those who may need them the most would have a negative affect on the quality of life for many of our residents. Our recommendation is that program fees remain unchanged.
