- A Tangible Business Personal Property Return for business equipment, tools and furnishings etc. (other than vehicles or trailers) owned as of January 1 must be filed by **March 1**/NEW DATE (or first business day thereafter) on the applicable form (Form 762B for Business Equipment, Form 762M for Manufacturing/Machinery & Tools, and Form 762P for Processors).
- If a business is not renewing its license because it closed or because it has gross receipts of less than \$4,000, it is
 important to notify the Commissioner's office so that your account record is updated accordingly and you are not sent a
 statutory assessment or a Summons for failure to file. Closed business notification form is available online at

BUSINESS WITH ESTIMATE OF LESS THAN \$4,000 OF TOTAL GROSS RECEIPTS

Please note that this exemption does not apply to licenses subject to a flat tax. Please complete and sign the form, reporting your estimated gross receipts, even if no license is required.
