

BUDGET WORK SESSION

FEBRUARY 22, 2016

A Budget Work Session of the Frederick County Board of Supervisors and Finance Committee was held on Monday, February 22, 2016 at 6:00 P.M., in the Board of Supervisors' Meeting Room, 107 North Kent Street, Winchester, VA.

CALL TO ORDER

Chairman DeHaven called the work session to order.

Administrator Garton began by reviewing the materials that were distributed to include revised tax rate scenarios, position allocation chart, County capital requests, and outside agency requests.

With regard to the revised tax rate scenarios, Administrator Garton advised that she had added a column reflecting a \$0.12 tax increase, which would increase the school's portion of the tax revenue. She advised that she would like to have some discussion on a proposal to increase the personal property tax rate on airplanes. She stated it was suggested that the rate be increased from \$0.01 to \$1.00, which would add about \$75,000 in new revenue. With regard to the transient occupancy tax rate, should the county's proposed legislation allowing the cap to be raised pass, she recommended considering raising the rate from 2% to 2.5%, which would generate approximately \$130,000, which could be used to fund tourism.

Supervisor Hess asked staff to try to identify some other expenditures, which could be categorized as tourism and then increase the rate to more than .5% to pay for them.

Administrator Garton advised the Board that unless she was directed otherwise she would be proposing a budget with a tax increase.

Vice-Chairman Fisher stated he could not support an increase in the personal property tax rate on airplanes. He went on to say the airport was an economic development tool and this increase could have a negative effect.

Supervisor Wells expressed his support for the airport as an economic development tool.

Commissioner Murphy advised that the reduction in the tax rate to \$0.01 a few years ago had not resulted in a change in the number of aircraft at the airport.

Chairman DeHaven stated he was opposed to a jump to \$1.00 but he was open to discussion.

Supervisor Lofton wanted a tax on pleasure aircraft that would make help to make the airport viable. He went on to say that he felt that rate should be \$1.00.

Vice-Chairman Fisher did not support changing the rate.

Chairman DeHaven stated he would be okay with \$0.50.

Mr. Ewing stated he could support \$1.00 because pleasure aircraft needed to pay for some use of the airport. He acknowledged that \$75,000 was not a lot of money, but was more of a principle. He concluded by saying he would support \$1.00 for advertising purposes.

Supervisor Wells supported \$1.00.

Supervisor Dunn suggested going back to the prior rate of \$0.42.

Supervisor Hess supported \$1.00, but he understood the importance of the airport from an economic development standpoint.

Supervisor Slaughter stated she would like to have more information regarding planes and fuel sales. She went on to say that she was not disagreeing that this was a fairness issue.

Supervisor Lofton stated he would like to have the EDA see what affect having an airport has on business location decisions. He concluded by saying that compared to other personal property and pleasure vehicles the tax rate seems out of balance.

Supervisor Dunn stated that he would like to see something put in this budget for debt reduction and he would like to see that money put against the principle in order to bring down costs.

Administrator Garton reviewed the position allocation chart, which was recommended for approval by the HR Committee.

Administrator Garton then reviewed the County's capital requests.

Supervisor Dunn expressed support for funding the school's critical needs of \$4.1, but he did not agree with funding the county side at this time.

The Board briefly reviewed the outside agency requests to include those agencies with an MOU or funding formula. They recommended not funding any new requests and no increases for those without a formula or MOU.

Chairman DeHaven opened the work session for Board comments.

Supervisor Dunn stated he might agree with a tax increase, but would like to see \$5 million to toward debt only.

Supervisor Hess hoped to advertise a higher rate than in the past as that would give time for additional discussion.

There being no further discussion, the work session was adjourned at 7:27 p.m.

CALL TO ORDER

Chairman DeHaven called the work session to order.

Administrator Garton gave a brief overview of her proposed FY2017 budget. The proposal contained a proposed \$0.08 real estate tax increase and an increase in the transient occupancy tax. She reviewed the positions proposed to be funded under this plan and discussed

the local dollars for schools. She advised that she was looking for direction regarding the personal property tax rate on airplanes.

Supervisor Dunn stated he would be comfortable with a rate that does not drive out planes.

Vice-Chairman Fisher recommended not changing the rate at this time.

Supervisor Slaughter concurred with Vice-Chairman Fisher. She went on to say that if the Board were to increase the tax rate, but lose fuel sales then it could result in no gain or maybe lost revenue.

Supervisor Lofton noted the Board did not study the rate when they decided to decrease it. Lowering the rate has not shown any improvement and he wished we had taken the time to study it when it was reduced the last time. He concluded by saying that he would like to see some action on this going forward.

The Board's consensus was to take this proposal off of the table for this year but look at is again next year.

Supervisor Dunn stated there were some things in the budget that he really liked, but he was concerned that we have \$120 million in debt coming along in the next five years. He was concerned about continuing tax increases. He went on to say if the Board could put \$5 million in a fund over the next five years it would have \$25 million to put towards the payment of the next school. He concluded by saying he would prefer that any extra money be used to pay down bonds, if possible.

Supervisor Hess agreed with Supervisor Dunn's concern of possible debt down the road, but he would rather set aside money to reduce future borrowing costs.

Supervisor Lofton noted that historically the County has mirrored Frederick County Schools regarding raises. With that in mind, he thought the proposed raise should be 2.6% instead of 3%. He went on to say that, according to the State Compensation Board, Frederick County has double the amount of recommended road and court deputies. He noted the Comp Board was not carrying the costs of the approved positions. He went on to say he was not sure where the discrepancy was or why there was a discrepancy. He concluded by saying he could not recommend funding any new deputy positions for the Sheriff's Department.

Supervisor Dunn stated that after giving the matter some additional thought he would recommend cutting the Sheriff's Department and Fire and Rescue position requests by half, based on the need. He suggested that they should have to come back next year to get the other positions created.

With regard to school funding, Supervisor Dunn stated that if the schools have significant capital needs this year he thought the Board should move away from the historic split of 57%-43% in order to address the school needs.

Administrator Garton stated her final item was getting a consensus from the Board regarding the proposed increase in the transient occupancy tax rate.

The Board's consensus was to go with a 0.05% increase.

There being no further business, the work session was adjourned at 6:50 P.M.

ELECTION OF CHAIRMAN

Upon a motion by Mr. DeHaven, seconded by Mr. Wiley, John Willingham was elected chairman of the Joint Finance Committee. The motion passed unanimously.

JOINT JUDICIAL CENTER CONSTRUCTION PROJECT UPDATE

Winchester Facilities Director Corey MacKnight reviewed the progress of the Joint Judicial Center renovation project. He noted that phase I should be completed by mid-March. The project estimate was originally \$3.7 million, but has since been revised to \$3.4 million. Approximately \$563,000 has been spent to date. He provided a brief overview of the remaining work and advised the entire project should be completed by October 2016.

WINCHESTER SHERIFF RENOVATION REQUEST

Winchester Sheriff Les Taylor stated he would like to construct an "L" shaped wall at the end of the existing counter in his office in order to provide an additional buffer between patrons and employees. He had received one bid for this project.

Ms. Freeman advised this project was outside of the current renovation project. The cost would be approximately \$6,000. She noted maintenance had always been a jointly shared cost between

the city and county.

Mr. Wiley suggested considering this as part of the renovations, if there was any extra money left from the project.

Mr. DeHaven stated he would like to leave it flexible but asked that the committee communicate back and forth, as it gets closer, regarding the cost.

OUTSIDE AGENCY UPDATE (BUDGET REQUESTS)

Ms. Shiffler and Ms. Blowe reviewed the requests received by the county and city from the various outside agencies.

Ms. Blowe noted these requests have not yet gone to city council for consideration.

Ms. Freeman provided a brief overview of the process the city uses to handle outside agency requests.

TOURISM REQUEST FOR FY 2017

Justin Kerns, Executive Director of the Winchester-Frederick County Tourism Office, appeared before the committee to review his department's FY 2017 budget request. He thanked both localities for historically funding tourism and then reviewed the spending numbers associated to tourism and associated taxes paid. He then provided a brief overview of the current tourism budget situation. He stated he was seeking additional funding to increase marketing and the current proposal of an additional \$50,000 per locality would allow him to increase advertising to 25% of the budget.

Ms. Freeman stated the city would work to try to get an increase in the budget to assist with marketing.

Ms. Garton updated the committee on Frederick County's request before the General Assembly to be added to list of counties who could increase the transient occupancy tax rate up to 5%. If the legislation were to pass then those additional monies above the current 2% rate would be allocated to tourism.

Chairman Willingham asked the county to keep the dialogue open if the legislation passes.

AIRPORT AUTHORITY

Ms. Freeman stated, over the last two fiscal years, the city has seen requests from the Airport to subsidize their budget due to decreased fuel sales. She suggested the Authority review the staffing and structure of the airport to try to address this issue.

Mr. DeHaven expressed his desire to have a continuing discussion on this issue because the way "we" are going is not sustainable.

THESE FUNDS WILL BE APPROPRIATED FOR CAPITAL. - APPROVED

Administrator Garton advised, as a result of the budget work session with the school board and the Board of Supervisors, there was a consensus to amend this years' budget to fund capital projects.

Chairman DeHaven convened the public hearing.

Shawn Graber, Back Creek District, stated he had a little heartburn with this. He had heard there would be \$3 to \$4 million left over from the Frederick County Middle School Project, which could be re-appropriated for these items. He asked that those additional funds be used for these projects. He concluded by asking the School Board to cut its budget 1/100% to cover these expenses.

Dr. David Sovine, Superintendent of Schools, highlighted the action of the School Board and stated they took action on the \$5.2 million of capital requests. He then highlighted some of the highest capital needs. He concluded by saying that the School Board acted on the VPSA application to fund the remainder of the projects if the Board of Supervisors appropriates the \$4 million from Fund Balance.

There being no further public comments, Chairman DeHaven closed the public hearing.

Upon a motion by Supervisor Lofton, seconded by Supervisor Hess, the Board approved the amendment to the Fiscal Year 2015-2016 budget.

PLANNING COMMISSION BUSINESS

PUBLIC HEARING

CONDITIONAL USE PERMIT #15-05 FOR THE WINCHESTER CHAPTER OF THE IZAAK WALTON LEAGUE, WHICH SUBMITTED FOR AN EXPANSION OF A NON-CONFORMING USE, FOR THE EXPANSION OF AN OUTDOOR RECREATION/SHOOTING AREA. THE PROPERTY IS LOCATED AT 2863 MILLWOOD PIKE, AND IS IDENTIFIED WITH PROPERTY IDENTIFICATION NUMBER 77-A-72 IN THE SHAWNEE MAGISTERIAL DISTRICT. - APPROVED

Zoning Administrator Mark Cheran appeared before the Board regarding this item. He advised this was an application for a conditional use permit for an outdoor recreation, non-conforming use, to expand a shotgun shooting range. The property is located at 2863 Millwood Pike and is zoned RA (rural areas) District. He stated this property showed no existing conditional use permit for the 149 acres; however, the use was established prior to this requirement being in place. He stated no increase in the intensity of the non-conforming use was permitted. The Planning Commission held a public hearing and recommended approval with the following conditions:

- 1. All review agency comments and requirements shall be complied with at all times.
- 2. Shooting activities shall be supervised by qualified personnel at all times.
- 3. Any expansion or change of use shall require a new conditional use permit.

He concluded by noting the airport did have an adverse comment relative to this proposal.

Supervisor Dunn asked if there would be a supervisor at the rifle range.

Zoning Administrator Cheran responded the range would have supervision.

Joan Fine, attorney for the Izaak Walton League, appeared before the Board on behalf of her client. She noted the shotgun range in addition to fishing and conservation programs on this property have been in existence since the 1960s.

Jim Sherry, President of the Winchester Izaak Walton League, stated the league had

addressed all of the problems and he did not expect any problems with the shotgun range. He noted as part of the conditional use permit application process, the league requested an FAA evaluation and the agency found the shotgun range did not pose a hazard. He advised a designated range supervisor would be present when the range was in use. He went on to say the facility is only available to members as long as a range supervisor is present. He concluded by saying the league had reached out to the nearest neighbors so they understand how the club operates and to address their concerns.

Warren Golightly, Shawnee District, stated the Izaak Walton League was morphing into a gun club with a lot of rapid fire weapons being fired from morning to evening, even on Sundays. This use disturbed the quiet enjoyment of his property to include his residence and the tenants in his rental properties. He stated this use affected the amount of rent he was able to charge. He concluded by saying he did not think the FBI would appreciate all of this shooting near their proposed new facility.

Ed Keenan, Shawnee District, noted he was an adjoining property owner and on February 21, 2016 he was called by Supervisor Dunn and met with him on Monday to look at the property. They also met with John Doyle, who was in charge of the high powered rifle range. He noted the league had installed a gate and he commended them for this addition. He stated that instead of seven days a week, he would like to see those hours reduced.

Carl Golightly, Shawnee District, stated he was concerned about safety. He went on to say that he had met with Ms. Manuel at Winchester Regional Airport and she was adamantly opposed to this application. He concluded by saying it was important to get some rules regarding the times people shoot.

Jeffrey Mitchell, III, Opequon District, in response to some comments concerning water

on the site advised there was a pond on this property and the property was bordered by the Opequon Creek. He stated no clay pigeons drop into the water.

Ed Keenan, Shawnee District, reiterated his concerns about safety. He noted alcohol could be on the property, but not on the ranges. He stated he would like to see the hours on Sunday start at noon due to the proximity of a church to this property.

There being no further comments, Chairman DeHaven closed the public hearing. Supervisor Lofton asked Mr. Keenan about week day hours.

Mr. Keenan responded that he was not too concerned during the week because most people have jobs.

Ms. Fine stated, with regard to the pistol and rifle range, the league is working on rules to make sure it is handled safely. She noted there were no illegal guns being used on the property. She reminded everyone that the league was here tonight about the shotgun range. She went on to say the trap launchers are locked in a building that can only be accessed when a range officer is present.

Upon a motion by Supervisor Fisher, seconded by Supervisor Dunn, the Board approved Conditional Use Permit #05-15.

Supervisor Fisher stated the application was for the shotgun range. He noted some cooperative effort had been going on and he understood the situation. He advised that he had spoken with Ms. Manuel and he understood why she issued her opinion. He stated that towers were not as tall as the trees and there was no obstruction to existing flight paths. He concluded by saying the shotgun range had no effect on the runway approach.

Supervisor Dunn stated he did not think there was a problem with the shotgun range.

Supervisor Hess moved to amend the hours of operation so shooting could not occur

before noon on Sunday.

Supervisor Lofton seconded the motion.

Supervisor Fisher stated he did not think the amendment was appropriate because the noise was coming from the grandfathered rifle range.

Supervisor Lofton withdrew his second.

The motion to amend died for lack of a second.





DATE:	March 4, 2016

At the budget work session held on Wednesday, February 24, 2016, the Board and Finance Committee discussed a possible 0.5% increase to the current 2% transient occupancy tax rate. This increase was enabled by legislation adopted by the General Assembly during the 2016 session and signed into law by the governor. The General Assembly legislation becomes effective July 1, 2016.

In order for the County to increase the transient occupancy tax rate, the County Code must be amended to reflect this increase. A public hearing is required in order to amend the County Code. At the February 24, 2016 budget work session, the Board's consensus was to move forward with the increase to the transient occupancy tax rate. In order for this proposed increase to be included as part of the FY 2016-2017 budget, the County Code amendment must be in place prior to budget adoption. Based on the Board's consensus, staff has advertised this matter for public hearing; however, we are seeking formal board endorsement of the public hearing request.

ORDINANCE March 23, 2016

CHAPTER 155 TAXATION

Article XIV Transient Occupancy Tax

§ 155-51 Tax imposed.

In addition to all other taxes of every kind now or hereafter imposed by law, there is hereby imposed and levied on each and every transient a tax equivalent to 2% 2.5% of the total amount paid for room rental by or for any such transient to any motel.

<u>Frederick County Inspections:</u> Proprietor occupied bed and breakfast and other transient boarding facilities not more than three stories above grade plan in height, that are also occupied as the residence of the proprietor, with a maximum of five guest room sleeping units provided for the transient occupants are permitted to be classified as either Group R-3 or R-5 provided that smoke alarms are installed in compliance with Section 907.2.11.2 for Group R-3 or Section 314 of the IRC for Group R-5

(R-5) Smoke alarms shall be listed and labeled in accordance with UL 217 and shall be installed in the following locations:

In each sleeping area

Outside each separate sleeping area in the immediate vicinity of the bedrooms

On each story of the dwelling, including basements and habitable attics

has no objection due to no increase of usage to an onsite sewage system. Property appears to be served by public sewer system.

Frederick County Sanitation Authority: No comments.

Frederick County Fire Marshall: Plans approved.

Winchester Regional Airport: No impact-no comments needed.

City of Winchester: No comments.

Planning and Zoning: This application for a Conditional Use Permit (CUP) is in response to a zoning violation complaint of a rooming house that was received by staff. Obtaining a CUP for this use is an available option to resolve the violation. A rooming house is permitted in the RP (Residential Performance) Zoning District with an approved CUP. This proposed use will take place within a four (4) bedroom house with two (2) rooms being rented at any given time. There will be no employees or signage associated with this CUP. The clientele of this use will be via the internet. The property is located within the Wakeland Manor subdivision. The property is surrounded by like dwellings. The 2030 Comprehensive Policy Plan of Frederick County (Comprehensive Plan) identifies this area of the County as part of the Southern Frederick Area Plan and is to remain residential in nature and is not part of any land use study.

STAFF CONCLUSIONS FOR THE 02/17/16 PLANNING COMMISSION MEETING:

Should the Planning Commission find this use appropriate, Staff would recommend the following conditions:

- 1. All review agency comments and requirements shall be complied with at all times.
- 2. No more than two (2) rooms rented at given time.
- 3. No employees allowed with this use.
- 4. No signage allowed with this use.
- 5. Any expansion or change of use shall require a new Conditional Use Permit.

PLANNING COMMISSION SUMMARY AND ACTION OF THE 02/17/16 MEETING:

Staff reported this is a request for a Conditional Use Permit (CUP) for a Rooming House. Staff explained a rooming house is permitted in the RP (Residential Performance) Zoning District with an approved CUP. Staff continued the proposed use will take place within a four (4) bedroom

house with two (2) rooms being rented at any given time. It was noted, there will not be employees or signage associated with this CUP. Staff concluded the property is located within the Wakeland Manor subdivision and is surrounded by like dwellings.

A Commission Member referred to the definition of a boarding or rooming house; if a family sponsors a foreign exchange student and they receive compensation for lodging and meals would that be considered a boarding/rooming house. The Member feels this is getting too deep into the privacy of citizens. Staff responded as the definition reads, it would be considered a boarding/rooming house when foreign exchange students are housed.

A Commission Member inquired how this CUP came about; was the Applicant cited for a violation. Staff explained this CUP transpired in response to a zoning violation complaint that was received by staff. A Commission Member inquired if a CUP would be required for foster care of children. Staff noted foster care would not require a CUP, and would be considered family.

A Commission Member asked how this CUP and the conditions would be monitored. Staff commented this would be addressed on a complaint basis. A Commission Member noted the conditions state two(2) rooms can be rented at a given time; he pointed out there is nothing listed citing how many people per room. Staff responded the conditions can be amended to add a number of persons per room.

A Commission Member noted according to legislation, this could turn into a by-right use by the summer of 2016.

The Applicant came forward to address questions and concerns. She presented an overview of the property and how she initially started renting a room to individuals. She noted she uses Airbnb to locate renters and feels comfortable with the security procedures they have in place. The Applicant highlighted the relationships she has established with her renters is outstanding.

A Commission Member asked if meals will be served as part of the renters stay. The Applicant replied the renters have access to the kitchen to prepare their own meals and the use of the kitchen has rules. A Commission Member inquired what the average length of stay is for the renters. The Applicant stated the average length of stay is approximately one (1) month. This Commission Member also requested clarification of what type of parking is available. The Applicant explained that both on-street and drive-way parking are options and VDOT is well aware of this.

A Commission Member inquired how many individuals usually occupy a room. The Applicant noted that one of the house rules is that only one (1) individual can occupy a room at a time.

The Public Hearing was opened and at that time seven (7) citizens came forward to speak. A variety of concerns were voiced by these citizens: An HOA is in place and the homeowner is

expected to abide by the rules of the HOA; Trespassing through neighboring yards; Fear more homeowners will want to open a rooming house; Not a good fit for a family oriented community such as Wakeland Manor; Security failures associated with Airbnb. The major concern of these citizens is the safety of the many children residing in this neighborhood. Chairman Wilmot noted the HOA does matter however the covenants and rules associated within cannot be part of the Planning Commission's decision.

A Commission Member requested clarification that a CUP is for the property and it would convey should the property be sold. Staff noted that is correct. A Commission Member expressed his feeling that the County should not be involved in this and that the property is not a good location to operate a rooming house.

A Commission Member noted the citizens may have civil recourse regarding the HOA.

A motion was made, seconded, and failed by majority vote to recommend approval of CUP #01-16 Sharlyn D. Moore for a rooming house.


An alternative motion was made, seconded, and passed by majority vote to recommend denial of CUP #01-16 Sharlyn D. Moore for a rooming house.


CONCLUSIONS FOR THE 3/9/16 BOARD OF SUPERVISORS MEETING:
