

PUBLI C HEARING

REZONING #02-16 FOR I-81 WEST BUSINESS PARK, SUBMITTED BY GREYWOLFE, INC. TO REZONE 36.676 ACRES FROM THE RA (RURAL AREAS) DISTRICT TO THE B-2 (BUSINESS GENERAL) DISTRICT, 45.453 ACRES FROM THE RA (RURAL AREAS) DISTRICT TO THE B-3 (INDUSTRIAL TRANSITION) DISTRICT AND 73.360 ACRES FROM THE RA (RURAL AREAS) DISTRICT TO THE M-1 (LIGHT INDUSTRIAL) DISTRICT, WITH PROFFERS. THE PROPERTIES ARE LOCATED ON THE WEST SIDE OF INTERSTATE 81 BETWEEN CEDAR HILL ROAD (RT. 671) AND HOPEWELL ROAD (RT. 672), AND ARE IDENTIFIED BY PROPERTY

<u>IDENTIFICATION NUMBERS 33-A-113, 33-A-124, AND 33-A-14B IN THE STONEWALL MAGISTERIAL DISTRICT. - APPROVED</u>

Assistant Planning Director Candice Perkins appeared before the Board regarding this item. She advised this was a request to rezone 155 acres from R-A (Rural Areas) District to B-2 (Business General), B-3 (Industrial Transition), and M-1 (Light Industrial) Districts with proffers. The property is located within the boundaries of the Northeast Land Use Plan and the Sewer and Water Service Area. She then turned the presentation over to Assistant Planning Director-Transportation John Bishop to review the Transportation proffers.

Assistant Director Bishop noted the key proffer was the 6,330 vehicle trips per day limitation. The applicant has proffered a 60 foot right-of-way for a potential future ramp access. He noted VDOT would like to see a signal warrant analysis performed and turn lane improvements associated with the new road. He concluded by saying the Planning Commission recommended approval and staff was seeking a decision from the Board regarding this application.

Gary Oates, GreyWolfe, appeared before the Board regarding this application. He began by saying that he had spoken with the applicant and they would like to change the \$0.05/square foot proffer to \$0.10/square foot for fire and rescue in order to be consistent with other rezonings in the area. He noted the applicant could not accommodate the interchange split on the property. He went on to say that the turn lane improvements in proffer 1A would be developed to VDOT standards. He advised, with regard to the signal warrant analysis, the applicant was not required to do one and they did not agree with VDOT's position. He stated the traffic impact analysis shows the development would not generate the need for a traffic signal. He noted the proposed Sanitation Authority tank was placed so far away because of the need for adequate water pressure. He stated this tank was only 10 feet higher than the minimum needed

for adequate water pressures. He concluded by saying no adjacent property owners had communicated any issues with this development to him.

Supervisor Lofton asked about any possible roadblocks to improving the road.

Mr. Oates responded there would be some significant challenges.

Chairman DeHaven convened the public hearing.

Darla Parson Barrett, Stonewall District, expressed concern about the possible impact this development would have on the Hopewell Road interchange. She noted a lot of heavy traffic comes into that area now.

There being no further public comments, Chairman DeHaven closed the public hearing.

Upon a motion by Supervisor Slaughter, seconded by Supervisor Hess, the Board approved Rezoning #02-16 with the revised fire and rescue proffer offered by the applicant.

WHEREAS, Rezoning #02-16, of I-81 West Business Park submitted by GreyWolfe, Inc., to rezone 36.676 acres from RA (Rural Areas) District to the B2 (General Business) District, 45.453 acres from the RA (Rural Areas) District to the B3 (Industrial Transition) District and 73.360 acres from the RA (Rural Areas) District to the M1 (Light Industrial) District with proffers to accommodate commercial and industrial uses, final revision dated April 7, 2016 was considered. The properties are located on the west side of Interstate 81 between Cedar Hill Road (Rt. 671) and Hopewell Road (Rt. 672). The properties are further identified with PIN(s) 33-A-113, 33-A-124 and 33-A-114B in the Stonewall Magisterial District; and

WHEREAS, the Planning Commission held a public hearing on this rezoning on March 16, 2016 and tabled the application for up to 30 days to allow for revised proffers to be submitted; and

WHEREAS, the Planning Commission held a public meeting on this rezoning on April 6, 2016 and recommended approval; and

WHEREAS, the Board of Supervisors held a public hearing on this rezoning on April 27, 2016; and

WHEREAS, the Frederick County Board of Supervisors finds the approval of this rezoning to be in the best interest of the public health, safety, welfare, and in conformance with the Comprehensive Policy Plan;

NOW, THEREFORE, BE IT ORDAINED by the Frederick County Board of Supervisors.

She advised staff received a request to revise the Zoning Ordinance to provide for an allowance to permit divisions from rural preservation lots for public road dedications or utility dedications. She noted staff had prepared a minor revision to provide an allowance for the boundaries of rural preservation lots to be modified, provided that the future division (subdivision) would only be allowed for the expansion of an existing VDOT owned road or for a public utility dedication. The proposed revision regarding public roads would allow for the widening of an existing VDOT road only. She advised the Development Review and Regulations Committee agreed with the proposed revision and the Planning Commission

recommended sending this revision forward to the Board for discussion. She concluded by saying staff was seeking Board direction regarding whether to send it forward for public hearing.

Upon a motion by Supervisor Lofton, seconded by Supervisor Hess, the Board approved sending this proposed ordinance forward for public hearing.

WHEREAS, an ordinance to amend Chapter 165, Zoning to allow dedications for Public Utilities and existing road right-of-ways on Rural Preservation Lots in the RA (Rural Areas) District was considered; and

WHEREAS, The Development Review and Regulations Committee (DRRC) reviewed the changes at their February 26, 2016 meeting and had minor revisions and sent the proposed amendment forward for review by the Planning Commission and Board of Supervisors; and

WHEREAS, the Planning Commission discussed the changes at their regularly scheduled meeting on April 6, 2016 and agreed with the amendment; and

WHEREAS, the Board of Supervisors discussed the changes at their regularly scheduled meeting on April 27, 2016; and

WHEREAS, the Frederick County Board of Supervisors finds that in the public necessity, convenience, general welfare, and good zoning practice, directs the Frederick County Planning Commission hold a public hearing regarding an amendment to Chapter 165; and

NOW, THEREFORE, BE IT REQUESTED by the Frederick County Board of Supervisors that the Frederick County Planning Commission shall hold a public hearing to allow dedications for Public Utilities and existing road right-of-ways on rural Preservation Lots in the RA (Rural Areas) District.



The Public Works Committee met on Tuesday, April 26, 2016, at 8:00 a.m. All members were present except Bob Wells and Jim Wilson. The following items were discussed:

Items Not Requiring Action

1. Demolition of the old Shawneeland Council House:

The Director presented a brief update of the status of the old Shawneeland Council House which continues to deteriorate. During the past three (3) years, efforts have been made to procure funding to stabilize the structural deterioration which was previously outlined in a report prepared by Ruckman Engineering. Several ad hoc committees have been appointed by the Shawneeland Advisory Committee to seek funding for this purpose. One of the committees even attempted to have the building included on the National Historical Registry. Unfortunately, this approach did not yield any funding to stabilize the structural deterioration. Consequently, the Advisory Committee during their March 7, 2016 meeting unanimously voted to demolish the building to eliminate a potential liability. To date, the Shawneeland staff has not scheduled the demolition.

2. Project Update:

- a) Round Hill Fire Station: The Deputy Director indicated that a substantial completion date of April 22, 2016 has been established and forwarded to the contractor for their signature. Issuing the substantial completion will allow the Round Hill Fire Company to occupy the Fire Station and Event Center.
- b) Landfill CDD Closure: Staff received three (3) bids for the closure of ten (10) acres of CDD Landfill space. The low bid was submitted by C. William Hetzer, Inc. of Hagerstown, Maryland, in the amount of \$2,125,770. This amount will be obtained from the landfill reserve fund. Staff had budgeted \$2,000,000 for this project. A contract will be awarded following approval by the Board of Supervisors.

- c) Snowden Bridge Boulevard: The Deputy Director indicted that this project was on schedule. The final road subgrade should be achieved by the end of this week. The construction of the west retaining wall which will support the bridge beams should be completed by mid May 2016. The actual placement of the bridge beams is scheduled for mid September 2016. Project completion is scheduled for mid December 2016.
- d) County Office Alleyway: The alleyway between the county office complex has received paving upgrades to eliminate standing water and further pavement deterioration. The total cost of this project was below staff's estimated budget.

3. North Mountain Fire Hall Bunk Room:

The committee briefly reviewed drawings prepared by Architect David Ganse to construct sleeping rooms within the existing North Mountain Fire Station. The committee unanimously endorsed the concept of the proposed alterations and recommended that the project be submitted to the Finance Committee for their review and approval of a supplemental appropriation.
